## TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: November 17, 2022 (1:00 PM) Summary of Decisions A. Bakshi

**1. Atiq Yavri** (Report No. 7753)
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. C217430)

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Vehicle-For-Hire Driver's Licence will be issued subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence(s) may be cancelled;
- (2) The Vehicle-For-Hire-Driver's Licence will be placed on probation for a period of three (3) years. ATIQ YAVRI is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against ATIQ YAVRI and conduct other investigations, as appropriate, to assess ATIQ YAVRI's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against ATIQ YAVRI or any other concerns with respect to the conduct of the licensee, those matters and report no. 7753 and any updating material, may be brought back before the Tribunal for a full hearing."

## 2. Michael John McDonald (Report No. 7758)

Applicant for a Tow Truck Driver's Licence (Application No. C222425)

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Tow Truck Driver's Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Michael John McDonald is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Michael John McDonald and conduct other investigations, as appropriate, to assess Michael John McDonald's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewal(s) of the licence, Michael John McDonald must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Michael John McDonald or any other concerns with respect to the conduct of the licensee, those matters and report no. 7758 and any updating material, may be brought back before the Tribunal for a full hearing."
