Purpose	To obtain authority to enter into a lease agreement with SAN PRO INC. (the " Tenant ") with respect to the to the property municipally known as 705 Progress Avenue, Unit 13 & 14, Toronto, for the purpose of printing and storage of signs and designs (the " Lease Agreement ").					
Property	The property municipally known as 705 Progress Avenue, Unit 13 & 14, Toronto, as shown on the Location Map in Appendix "A", comprising approximately 4,068 sq. ft. (the "Premises").					
Actions	1. Authority be granted to enter into the Lease Agreement with the Tenant, substantially on the major terms and conditions set out in Appendix " B ", and including such other terms as deemed appropriate by the approving authority herein, and in a form satisfactory to the City Solicitor.					
Financial Impact	705 Progress Avenue is a jointly owned facility between the City of Toronto and Toronto District School Board (collectively, the "Landlord"). Net revenues collected are divided equally between the parties. The City's portion of total revenues is \$57,969.00 (plus HST), based on the total minimum rent from the lease agreement of \$115,938.00 (plus HST), for the period of thirty-six (36) months commencing April 1, 2021 and ending March 31, 2024 of the Lease Agreement, as per below table. The City's net revenue portion will be transferred to the dedicated parkland reserve fund (5% and 2% Land Acquisition Reserve Fund Scarborough - XR2007) less the management fee to be directed to the 2022 Council Approved Operating Budget for Corporate Real Estate Management (CREM), under cost centre FA1378 and will be included in future operating budget submissions for Council consideration. Comments	identified in the Financial Impact section. 705 Progress Avenue is an industrial mall type of property consisting of approximately 156,000 square feet acquir in August, 1996 by the former City of Scarborough in partnership with the former Scarborough Board of Educati (the "Board"). Pending development of the property as a future park and a school facility, it was decided to contin to lease the units to multiple tenants. Former City of Scarborough and the Board entered into an Operati Agreement dated January 2, 1997, which provided that the City, in consultation with the Board, would engage property manager (currently Compass Commercial Realty LP) and enter into a management agreement. 


