

Request to Review Commemorative Street Name, Property Name or Monument Application

Use this form to request that the City of Toronto review an existing commemorative street name, property name or monument in Toronto's public spaces that may be considered troublesome, harmful or problematic. Learn more about the City's Request to Review process <u>here</u>.

In addition to completing this form and providing an explanation for why the City should review an existing commemorative street name, property name or monument, you must provide documented support from other people regarding your request to review.

Note: Due to the extensive research required to review existing commemorative street names, property names or monuments, the City may take up to one year or more to reach a resolution.

Section 4 – Reason(s) for Your Request to Review

Why should the City of Toronto review the commemorative street name, property name or monument that you identified in Section 3 of this form? Select all that apply.

□The name or monument refers to a current or historic person known for their discriminatory views and actions, including committing or perpetuating acts of racism or violence against Indigenous Peoples, Black communities and/or *equity-deserving groups.

□The name or monument includes derogatory terms that might represent or be linked with discriminatory views and actions.

□The name or monument negatively represents or appropriates the culture of Indigenous Peoples, Black communities and/or *equity-deserving groups.

□The name or monument is inconsistent with City bylaws or policies including the City of Toronto Human Rights and Anti-Harassment / Discrimination Policy.

□The name or monument brings the City of Toronto into disrepute (e.g., the name or monument negatively impacts the reputation of the City of Toronto).

*Equity-deserving groups include racialized people; newcomers; persons with disabilities; women; youth; persons with low income; and Two-Spirit, lesbian, gay, bisexual, trans, queer+ communities. Examples of racialized people include East Asian, South Asian, Southeast Asian, West Asian, Indo-Caribbean, Arab, Middle Eastern, Latin American. Examples of newcomers include immigrants, refugees who have recently arrived in Toronto, refugee claimants, temporary residents, and undocumented persons.

When submitting this form, please include a separate document describing your explanation for your request to review. Answer the following questions in any order.

- What is problematic, troublesome or harmful about the commemorative street name, property name or monument?
- Where did you find information and/or how did you learn about the history or story of the commemorative street name, property name or monument?
