(the "Tenant") with respect to the property **Purpose** municipally known as 705 Progress Avenue, Unit 7, Toronto, for the purpose of equipment showroom and warehouse (the "Lease Agreement"). The property municipally known as 705 Progress Avenue, Unit 7, Toronto, as shown on the Location Map in Appendix **Property** "A", comprising approximately 2,023 sq. ft. (the "Premises"). 1. Authority be granted to enter into the Lease Agreement with the Tenant, substantially on the major terms and Actions conditions set out in Appendix "B", and including such other terms as deemed appropriate by the approving authority herein, and in a form satisfactory to the City Solicitor. **Financial Impact** 705 Progress Avenue is a jointly owned facility between the City of Toronto and Toronto District School Board (collectively, the "Landlord"). Net revenues collected are divided equally between the parties. The City's portion of total revenues is \$27,310.50 (plus HST), based on the total minimum rent from the lease agreement of \$54,621.00 (plus HST), for the period of thirty-six (36) months commencing October 1, 2021 and ending September 30, 2024 of the Lease Agreement, as per below table. The City's net revenue portion will be transferred to the dedicated parkland reserve fund (5% and 2% Land Acquisition Reserve Fund Scarborough - XR2007) less the management fee to be directed to the 2022 Council Approved Operating Budget for Corporate Real Estate Management (CREM), under cost centre FA1378 and will be included in future operating budget submissions for Council consideration. Rents pertaining to 2021 were received in the respective fiscal year. 2021: \$ 4,298.87 (plus HST) 2022: \$17,448.38 (plus HST) 2023: \$18,459.88 (plus HST) 2024: \$14,413.87 (plus HST) Total: \$54,621.00 (plus HST) The tenant is responsible for the Proportionate Share of realty taxes, building insurance and maintenance, as well as all other operating costs of the building including water, gas, hydro, heating and air conditioning. The Chief Financial Officer and Treasurer has reviewed this DAF and agrees with the financial implications as identified in the Financial Impact section. 705 Progress Avenue is an industrial mall type of property consisting of approximately 156,000 square feet acquired in Comments August, 1996 by the former City of Scarborough in partnership with the former Scarborough Board of Education (the "Board"). Pending development of the property as a future park and a school facility, it was decided to continue to lease the units to multiple tenants. Former City of Scarborough and the Board entered into an Operating Agreement dated January 2, 1997, which provided that the City, in consultation with the Board, would engage a property manager (currently Compass Commercial Realty LP) and enter into a management agreement. The City and the property manager would be responsible for the day-to-day operation of the property. There are no plans at the present time to carry out the intended uses by the City and the Board for the property. The proposed rent and other major terms and conditions of the Lease Agreement are considered to be fair, reasonable and reflective of market rates. Toronto District School Board (TDSB) acknowledged the receipt of the Tenant's basic information, along with Appendix A and B enclosed in this DAF. See Appendix "B". 




