
Construction began on October 25, 2022 and will be completed by June, 2023* *Timeline is subject to change.

This notice provides an update on the contractor's working hours.

The City's contractor will begin working extended hours from 7 p.m. to 11 p.m. for specific construction tasks in order to expedite the work and minimize the inconvenience to the public. The first tasks involve the installation of roadway protection (sheet piling) and excavation, which involves some noise and vibration.

We realize that this project has an impact to businesses and residents along Jane Street. We appreciate your patience and apologize for inconvenience.

WORK STATUS TO DATE

The City's contractor has:

- Completed a temporary widening on the east side of Jane Street for the traffic staging.
- Removed all trees needed to facilitate construction of the new culvert and the creek restoration/erosion protection measure.
- Implemented the first stage of the traffic control in order to work on the west half of Jane St.
- Removed asphalt on the west half of Jane St.

REMAINING WORK

- Installation of a protection system for the active portion of the roadway.
- Excavation on west side of Jane Street.
- The contractor will proceed with excavation to the foundation level of the culvert.
- Install temporary flow passage system for the creek.
- Remove and bypass existing sanitary sewer.
- Install all culvert components
- Install new sewers connected to the culvert.
- Backfill and pave.
- Switch traffic to the west half of Jane St to repeat the construction on the east half.

WHAT TO EXPECT DURING CONSTRUCTION

• You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts and apologize for any inconveniences. We appreciate your patience.
