# 2025 Water rates and fees

As part of the 2025 budget, Toronto City Council approved a 3.75 per cent water rate increase effective January 1. For the average household, this means an annual increase of \$39 (based on 230 cubic metres of water consumed per year).

Effective, January 1, 2025, the approved water rebate for eligible low-income seniors and lowincome people with disabilities will be set at a rate of \$1.4062 per cubic metre, representing a 30 per cent reduction in the Block 1 rate. Learn more: toronto.ca/TaxAndUtilityRelief.



# belongings.


- Ensure the grading around your property slopes away from the foundation wall.
- Seal cracks and leaks in your home's foundation, basement walls, windows and doors.
- Keep eavestroughs clear of leaves and debris to help proper drainage.

The City continually updates and maintains Toronto's complex network of underground pipes, sewers and catch basins. The City offers up to \$3,400 in subsidies for basement flooding prevention devices. Learn more: toronto.ca/BasementFlooding.

\*Bag-only rates are available for locations with special approval from the City. The bin program is otherwise mandatory for curbside customers. Bag-only customers are also required to buy a Garbage Tag for each bag they set out.

If your household no longer needs a Garbage Bin as large as the one you have, you can save money by downsizing to a smaller bin. All you have to do is submit a Service Request to exchange your Garbage Bin at toronto.ca/311 or via the 311 Toronto mobile app.

# Vacant Home Tax

If you own a house or condo in Toronto, you need to make a Vacant Home Tax declaration every year – even if you live at your property. The program supports the City's ongoing efforts to increase housing availability and affordability by encouraging property owners to rent or sell vacant properties. The declaration period for the 2025 calendar year opens in the fall. Learn more: **toronto.ca/VacantHomeTax.** 

### Property Tax, Water and Solid Waste Relief Programs

Are you a low-income senior or low-income person living with a disability and own a residential property? You may be eligible for the City's tax and utility relief programs. Apply online so your household income can be verified by Canada Revenue Agency – and you won't have to gather income documents. The deadline to apply is October 31, 2025. Visit **toronto.ca/TaxAndUtilityRelief**, or call 311 - Tax & Utility Line for details.

### Estimated utility bills

The City of Toronto is dealing with an unexpected increase in the premature failure of water meter transmission units. These battery-powered devices are connected to water meters and send meter readings to the City for billing purposes. While some transmitters are not working, the water meters themselves continue to record actual water consumption. When a transmitter stops sending data, the City uses estimated billing to charge for water based on previous consumption at the property. The City is working with the supplier on the replacement plan for failed transmission units.

The City has set up a dedicated customer care team to provide service and answer questions. The call centre can be reached by calling 311 (416-392-2489 if outside Toronto).
