

Yorkdale Transportation Master Plan

Municipal Class Environmental Assessment Notice of Study Completion

The City of Toronto has completed the Yorkdale Transportation Master Plan (TMP) with the purpose of supporting the significant plans for growth and development both on the Yorkdale Shopping Centre lands as well as in the surrounding area. The TMP study followed the Municipal Class Environmental Assessment (EA) process.

The TMP identifies transportation infrastructure, programs and policies that will support the growth identified in the Yorkdale Shopping Centre Block Master Plan and builds upon previously approved secondary plans in the area including the Dufferin Street Secondary Plan and the Lawrence Allen Secondary Plan.

Some of the pedestrian, cycling, transit and road intersection improvement projects identified in the TMP are Schedule 'A+' or 'B' which may proceed to detailed design and construction at any time. Several projects may be delivered through private development. Other infrastructure projects identified in the TMP are Schedule 'C' projects and require additional study and consultation following the completion of the TMP to meet the requirements of the Environmental Assessment process.

Opportunities for Review

The TMP will be placed on public record for a **30-day review** period starting January 19 and ending February 17, 2023.

A request may be made to the Ministry of the Environment, Conservation and Parks for an order requiring a higher level of study, or that conditions be imposed, only on the grounds that the requested order may prevent, mitigate or remedy adverse impacts on constitutionally protected Aboriginal and treaty rights.

Requests on other grounds will not be considered. Requests must include your contact information and be received by February 17, 2023. Requests should specify what kind of order is being requested (request for conditions or a request for an individual/comprehensive environmental assessment), how an order may prevent, mitigate or remedy potential adverse impacts on Aboriginal and treaty rights, and any information in support of the statements in the request.
