## Road Resurfacing on Cramond Court, Dornoch Drive, Mossford Court, and Pentland Place

Contract: 22ECS-TI-13LR

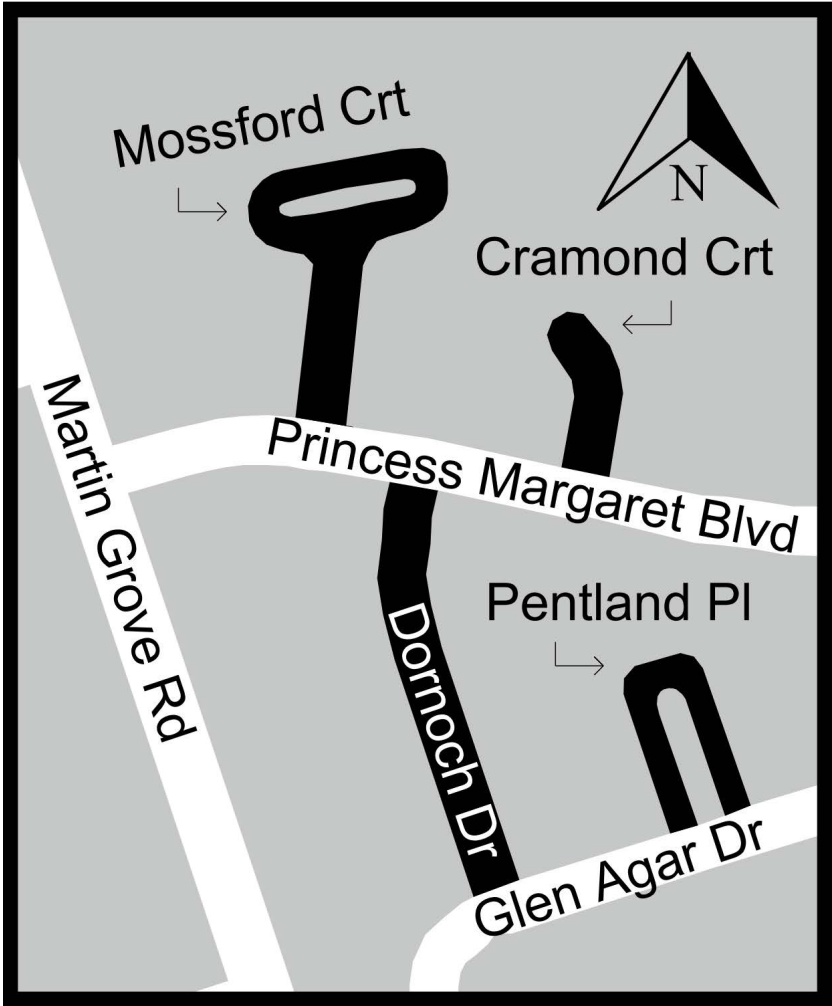
On March 9, 2023 the City of Toronto issued a notice of road resurfacing work taking place in Etobicoke Center this year. The approximate project schedule is:

**Start Date: April 10, 2023, End Date: September 12, 2023**

These dates represent the earliest start date in the area. If more than one street in your area is being resurfaced, as shown on the map below, then the exact start date on your street may vary. The timeline for construction is subject to change.

This project is part of the Council-approved 2023 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

|    | <p><b>Parking Violation Notice:</b> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</p> <ol style="list-style-type: none"><li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li><li>2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.</li></ol> <p><b><i>You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note:</i></b> violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.</p> |
|  | <b>Telephone and Internet Services:</b> This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. The contractor will coordinate with utility companies to minimize disruption.
