TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: April 13, 2023 (9:30 AM) Summary of Decisions D. Simon

1. Ibrar Javed (Report No. 7792)
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. C240665)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on April 12 (by Ibrar Javed) and April 13, 2023 (by Municipal Licensing and Standards), as follows:

"Vehicle-For-Hire Driver's Licence be issued subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence(s) may be cancelled;
- (2) The Vehicle-For-Hire Driver's Licence will be placed on probation for a period of **Three (3) years**. Ibrar Javed is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Ibrar Javed and conduct other investigations, as appropriate, to assess Ibrar Javed compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ibrar Javed or any other concerns with respect to the conduct of the licensee, those matters and report no. 7792 and any updating material, may be brought back before the Tribunal for a full hearing."

2. Chayse James Shawn Freeman (Report No. 7780)
Applicant for a Tow Truck Driver's Licence (Application No. C236620)

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Tow Truck Driver's Licence be issued subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence(s) may be cancelled;
- (2) Chayse James Shawn Freeman Tow Truck Driver's Licence will be issued and suspended for <u>Three</u> (3) days. The suspension shall begin from the day the licence is issued.
- (3) The Tow Truck Driver's Licence will be placed on probation for a period of <u>Five</u> (5) years. Chayse James Shawn Freeman is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Chayse James Shawn Freeman and conduct other investigations, as appropriate, to assess Chayse James Shawn Freeman's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Chayse James Shawn Freeman or any other concerns with respect to the conduct of the licensee, those matters and report no. 7780 and any updating material, may be brought back before the Tribunal for a full hearing."
