The City of Toronto's Burial Portal will be updated on April 25, 2023.

A new version of the Burial Portal is being released on April 25, 2023. This new version will help funeral service providers by:

- prioritizing urgent and time sensitive requests;
- improving communication with stakeholders when a request is declined;
- providing more detail for stakeholders on the status of a death registration; and
- enabling stakeholders to retrieve a copy of the documents submitted to the Burial Portal.

There are three main changes to that will impact submissions to the Burial Portal:

There are three main changes to the portal that will impact your submission and receipt of a burial permit. Please review.

1. Funeral Service Providers <u>must now enter the date and time of disposition</u> when submitting a burial permit request.

Every time your submit a burial permit request, you must enter the dispositon date and approximate time of the disposition – these are mandatory fields. This information will help us to identify urgent and time sensitive requests.

There are five new fields to track information and improve burial permit service delivery and tracking.

- 1. <u>Processed Date</u>: This is the date the burial permit is issued, and marks the beginning of the Death Registration process.
- 2. <u>Disposition Date</u>: The date the deceased is disposed. Including this information helps us identify urgent and time sensitive requests.
- **3.** <u>Last Update</u>: This is the last date and time that we reviewed/changed the request's status. This information helps you know that we are working on it.
- 4. <u>Actions</u>: The table below outlines the required actions depending on the status of the request

Status	Action Required
Issued	Click the "Download Permit" button to retrieve the signed burial permit.
Declined	Click the "View Message" button to view a message explaining the reasons the request was declined.
Registered	Correct the errors on the request and re-submit the entire request to the portal We have completed processing the death registration, and the original documents
	have been sent to the Office of the Registrar General (ORG). Contact the ORG directly at 1-800-461-2156 for any further inquiries regarding the death registration. Email <u>registryservices@toronto.ca</u> for assistance if the ORG requires courier tracking information to locate the registration.
