# Hwy 27 Bridge Rehabilitation over Mimico Creek


Contract: 23ECS-BE-05BSE

Start Date: April 13, 2023, End Date: December 22, 2023

The City of Toronto is planning to rehabilitate the Hwy 27 Bridge over Mimico creek. This work will ensure that the bridge meets today's standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2023 Capital Works Program.

## **WORK DETAILS**

The City's contractor will:

- Repair and refurbish the existing Hwy 27 Bridge over Mimico creek
- Reconstruct the concrete barriers and approach slabs
- Replace concrete deck overlay, and rehabilitate substructure and retaining walls
- Replace the asphalt surface and waterproofing

#### WHAT TO EXPECT DURING CONSTRUCTION

 You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.



**Work Hours:** Work will take place from 7 a.m.to 10 p.m., Monday to Friday, Saturday and Sunday, 9:00 am to 7:00 pm. No work on Civic/Statutory Holidays.



**Traffic Management**: Road users should expect delays. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.

There will be no reduction in the number of lanes, but lane width and orientation will be impacted to accommodate construction.



**On-Site Communication:** There are times when contractors need to communicate with property owners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing and will follow relevant COVID protocols. If you need to speak with staff on the construction site,

	please ask for the Site Inspector and follow public health directions for reducing the spread of COVID-19 during in-person communication.
Ė	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the Field Ambassador listed below.
