## Road Resurfacing on Dogwood Crescent

**Contract: 22ECS-TI-13LR**

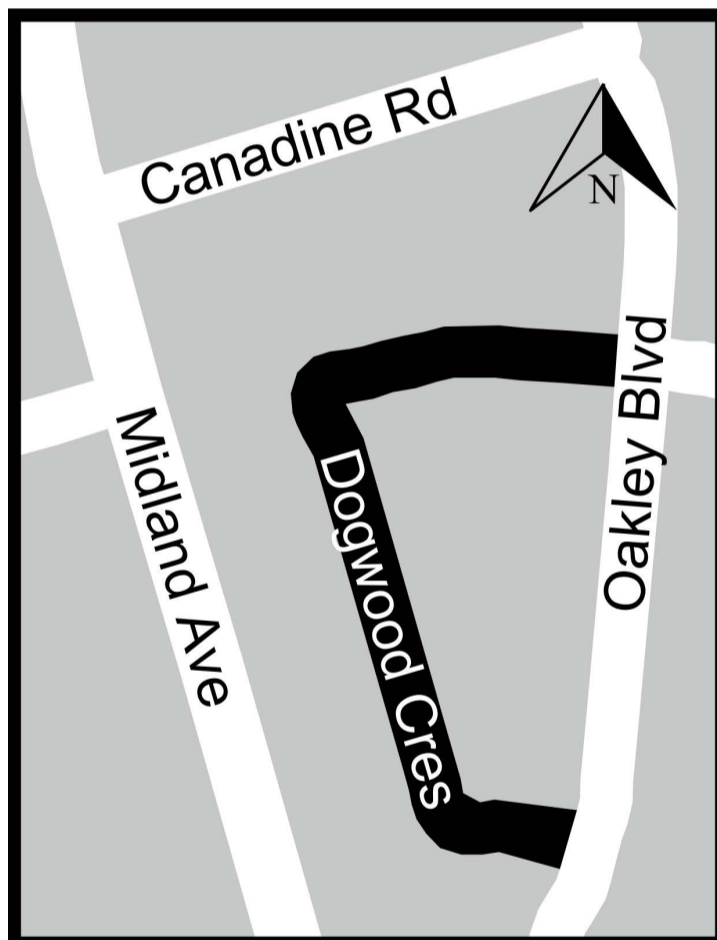
On March 9, 2023 the City of Toronto issued a notice of road resurfacing work taking place in Scarborough Centre this year. The approximate project schedule is:

**Start Date: April 17, 2023, End Date: November 7, 2023**

These dates represent the earliest start date in the area. If more than one street in your area is being resurfaced, as shown on the map below, then the exact start date on your street may vary. The timeline for construction is subject to change.





This project is part of the Council-approved 2023 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

### IMPORTANT REMINDERS

The Pre-Construction Notice issued by the City of Toronto on March 9, 2023 contains additional information about construction impacts. 	<p><b>Accessible Accommodation:</b> Residents who require accommodation (level entry, longer notice, etc.) must contact the <b>Field Ambassador</b> to arrange for access during the construction period.</p>
	<p><b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.</p>
	<p><b>Parking Violation Notice:</b> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:</p> <ol style="list-style-type: none"> <li>1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.</li> <li>2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.</li> </ol> <p><b>You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note:</b> violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones).</p> <p>In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.</p>
	<p><b>Telephone and Internet Services:</b> This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. The contractor will coordinate with utility companies to minimize disruption. Residents who find their service has been disrupted should contact the <b>Field Ambassador</b> <u>and</u> notify their phone or internet service provider.</p>
