Toronto Local Appeal Body – Proposed Addition of New Rule 2.17 to the Toronto Local Appeal Body's *Rules of Practice and Procedure* regarding the Resignation of a Member During a Hearing.

#### Summary

A new Rule 2.17 is proposed to address the resignation of a TLAB Member during a proceeding and before a decision has been issued. The current TLAB *Rules of Practice and Procedure* deal only with circumstances in which a Member's term expires during a hearing. The draft Rule confers discretion upon the TLAB Chair to appoint another Member to review the transcripts, complete the hearing, and issue a decision.

New Rule 2.17 – "If a Member presiding over a Hearing resigns from the TLAB before a decision or determination in a Proceeding is given, the Chair may appoint another Member to review the transcript of the Proceeding to date, complete the Proceeding, and issue a decision."
