## 18 Twenty Fourth St – A0145/22EYK

Originally Approved by Committee, Appealed by City of Toronto Legal Services and the Long Branch Neighbourhood Association. City of Toronto withdraws Appeal, LBNA continues with Appeal. Settlement reached on revised set of variances, but City of Toronto could not support the revised proposal. Therefore the Appeal hearing proceeds on original proposal. Appeal is refused. Variances are Authorized subject to Conditions.

Originally Refused by Committee, Appealed by Owner. Appeal is Abandoned and therefore Dismissed. Variances are NOT Authorized.
