DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on July 18 (by Arlindo Resendes Soares) and July 19, 2023 (by Municipal Licensing and Standards), as follows:

"A Body Rub Parlour Owner/Operator's Licence be issued to 1000503527 Ontario Inc. subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Elliott Stone shall not be involved in the operation or management of the Body Rub Parlour owned and operated by 1000503527 Ontario Inc. at 3598 Dufferin Street, Toronto, Ontario and shall only be permitted to enter the said Body Rub Parlour one time each calendar month when it is closed for business to collect rent and view the state of repair of the premises in his capacity as landlord."
