### Watermain Replacement and Road Improvements on Martin Grove Road from Lorraine Gardens to North of Rathburn Road

Contract: 23ECS-LU-03SU Start Date: August 14, 2023 End Date: July 2024 \*Timeline is subject to change.

The City of Toronto plans to replace the watermain and the City-owned portion of substandard water services on Martin Grove Road from Lorraine Gardens to just North of Rathburn Road. The water service is the underground pipe that brings water to your water meter and is owned by you and by the City. The part you own is from your house to the end of your property, the part the City owns is from the end of your property to the watermain.

In addition, the City of Toronto will be performing local road improvements on Martin Grove Road as listed below.


- Improvements to the Martin Grove Road / Rathburn Road intersection including corner radius reductions, traffic signal upgrades, and audible pedestrian signals.
- New bike lane pavement markings on Martin Grove Road from north of Burnhamthorpe Road to Rathburn Road and upgrade of bikeway pavement markings from Rathburn Road to 165 m north of Rathburn Road.

This project is part of the Council-approved 2023 Capital Works Program to renew our aging infrastructure, improve water distribution and reduce the risk of watermain breaks.

#### IMPORTANT INFORMATION ABOUT LEAD WATER SERVICES

If you live on Martin Grove Road in a house that was built before the mid-1950s, your water service may be made of lead. Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house is pregnant, there are children under six years old, or there is an infant drinking formula made using tap water.

The City's contractor will:

- excavate the road and dig a trench to access and install the new watermain
- replace any City-owned water service pipes that do not meet City standards from the watermain to the private property line

• resurface the road

#### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.
- Work in the boulevard in front of homes and commercial properties is expected. This work includes removing and replacing driveways, municipal sidewalks and grassed boulevards, where necessary.

The inspection will look at the interior and exterior of all properties to verify existing conditions. Although participation is voluntary, the City encourages all homeowners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction.  |  |
|                              | Affected properties will receive a separate notice to set up an appointment. All inspection staff will wear photo I.D. and carry photo equipment for this work.  |  |
|                              | <b>On-Site Communication:</b> There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing and will follow relevant COVID protocols. If you need to speak with staff on the construction site, please ask for the Site Inspector and follow public health directions for reducing the spread of COVID-19 during in-person communication.       |  |
| <b>A</b>                     | Important information for owners of sprinkler systems / heated driveways<br>and private landscaping features. Property owners should remove items<br>located within City property limits (boulevard) to avoid damage.  |  |

|                              | <b>Water Service Disruptions:</b> From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide notice at least 24-hours in advance. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not receive advance notice, the City may have needed to use an <i>emergency water shut off</i> to complete work. |  |
| L <sub>ing</sub>             | <b>Substandard Water Service Replacement:</b> Please take the time to read the attached fact sheet carefully as it contains important information on lead in drinking water and how to prepare for replacement. # **Construction Notice**

| <b>Restoration:</b> The construction work area will be restored with sod, concrete<br>and/or asphalt where required. Interlocking bricks, flagstone on a granular base,<br>or other similar features that are removed from public and private property during<br>construction will be replaced. Lawn seeding and/or laying of sod will be done as<br>needed during ideal growing seasons only - April to June and September to<br>October. |

| <b>Parks and Trails:</b> Due to the nature of this work areas of Ravenscrest park will be affected. Sections of the park / trail will be fenced off and closed for public safety. Signs will be posted. All areas of the park and trail affected by construction will be restored.   |
| <b>Tree protection Zone:</b> Temporary Tree Protection Fencing/Hoarding will only be installed around the Tree Protection Zone (TPZ) based on the type of work. If needed the temporary tree protection fencing/hoarding will be installed prior to working near a tree and will be removed as the work progresses. All required steps are taken to minimize the damage to the trees.  |
