Subject:	Invitation to Mandatory Training About Notice of Collection and By Name List Consent Changes Being Implemented in SMIS
Bulletin:	 This Bulletin provides information about: The Notice of Collection (NoC) and By Name List (BNL) Consent changes that will be implemented in SMIS Mandatory training sessions being offered to support homelessness service providers be prepared for the SMIS update scheduled for September 20, 2023.
	Updates to the NoC and BNL Consent Form, are scheduled for September 20, 2023 for all sites and street outreach services.
	These changes ensure that: 1) all clients are presented with the NoC statement <i>before</i> their information is collected and 2) that clients provide informed consent to be considered for the housing and support resources available through the City's Coordinated Access process. These changes to SMIS contribute to the implementation of a Coordinated Access System in Toronto and support improved privacy and information practices. Implementing a By Name List Consent is a mandatory system requirement through Reaching Home and Homelessness Prevention Plan funding.
Training:	 Training for SMIS users is offered in 2 formats: 1. Live sessions for supervisors and managers who oversee client-facing staff. Three live sessions will be offered, see details below. Supervisors and Managers are asked to select one live session to register and attend. 2. pre-recorded self-directed e-modules.
