# ROAD CLOSURE on Symes Road from Terry Drive to Glen Scarlett

Contract: 22ECS-TI-103LR


Start Date: October 2, 2022 | Expected End Date: late October 2023

This notice provides an update on the upcoming Symes Road closure. Symes Road is scheduled to be closed from Terry Drive to Glen Scarlett during daytime hours for approximately three weeks for City infrastructure work starting Monday October 2, 2023, and will last for approximately 3-4 weeks weather dependent. The road closure will start from Terry Drive and extend east to Glen Scarlett Road. Refer to map below.

Symes Road will be reopened every evening after construction activities and on the weekends. All businesses on Symes Road will maintain access during construction. We know this project has an impact to all businesses along Symes Road, we appreciate your patience during this road closure.

### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

	<b>Work Hours</b> : Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.
8	<b>Traffic Management</b> : Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.
Symes Road Daily Road Closures: During work on Symes Road the daily road closures to complete road construction. This work is expected completed within 3-4 weeks.

## Construction Update #1

Ġ	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
	If you do not have a copy of the Construction Notice, please contact 311 to request a copy. <b>Please note</b> : Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in No Parking zones). In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
	<ul> <li>with no charge to the owner. Please call 416-808-2222 for its location.</li> <li>Parking Violation Notices: Please ensure you park in a legal parking spot at all times. If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date in order to avoid additional fines or records being kept of non-payment:</li> <li>1. Pay the parking violation (follow instructions on the back of the notice) or</li> <li>2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.</li> </ul>
R	<b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated
大	<b>Pedestrians:</b> The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.
	<b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.
÷	<b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.
