DECISION:

The Tribunal approved the removal of the conditions on Eating Establishment Licence No. B71-5107281, on consent.

Municipal Licensing and Standards requested the following conditions previously placed on the licence at the October 7, 2021 Hearing be removed and Ke Zhi Liu, Director agreed to the request:

- (1) The matter shall be adjourned sine die, pending the disposition of the criminal charges laid on April 1, 2018 and August 2, 2018, or sooner if either party so requests;
- (2) Yuan Lu Shao shall not be permitted to enter the premises of the eating establishment at 2202 Danforth Avenue, Toronto, Ontario, during business hours, unless he is being supervised by another employee, and shall not be alone with customers at any time;
- (3) Ke Zhi Liu shall inform Municipal Licensing and Standards (MLS) of any disposition of the charges against Yuan Lu Shao, in writing, within three (3) business days. Ke Zhi Liu can notify MLS in one of the following ways:
