4. Sarfraz Ahmed (Report No. 7820)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. C319599)

DECISION:

The Tribunal approved the joint Proposed Resolution signed on September 28, 2023, as follows:

"Vehicle-For-Hire-Driver's Licence be issued subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence(s) may be cancelled;
- (2) The Vehicle-For-Hire-Driver's Licence will be placed on probation for a period of **One (1) year**. SARFRAZ AHMED is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against SARFRAZ AHMED and conduct other investigations, as appropriate, to assess SARFRAZ AHMED's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next **One (1) year** renewal(s) of the licence, SARFRAZ AHMED must provide to Municipal Licensing and Standards, at their own expense, an original up-to-date abstract of their Criminal Record and Judicial Matters Check:
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against SARFRAZ AHMED or any other concerns with respect to the conduct of the licensee, those matters and report no. 7820 and any updating material, may be brought back before the Tribunal for a full hearing."

5. Jahan Zeb Afzal (Report No. 7860)

Holder of Toronto Taxicab Owner's Licence No. V02-4868560; Taxicab Plate No. 1903

DECISION:

The Tribunal approved the temporary suspension of Toronto Taxicab Owner's Licence No. V02-4868560; Taxicab Plate No. 1903, on consent, subject to the following conditions:

- Jahan Zeb Afzal is to register a new vehicle with Municipal Licensing and Standards that complies with conditions of Chapter 546-51 of the Toronto Municipal Code;
- (2) Jahan Zeb Afzal is to return Taxicab Plate No. 1903 to Municipal Licensing and Standards at 850 Coxwell Avenue, Toronto, Ontario, M4C 5R1;
- (3) The temporary suspension of Toronto Taxicab Owner's Licence No. V02-4868560 will be lifted after any one (1) of the two (2) above conditions are satisfied.
