# O'Connor Drive Improvements Glenwood Crescent to Bermondsey Road

Contract: 20ECS-LU-03FP
Start Date: Mid-November 2022 NEW Planned End Date: Summer 2024
\*Timeline is subject to change

This notice provides an update on the O'Connor Drive Improvements project.

The project now includes watermain replacement on O'Connor Drive between Sandra Road and Bermondsey Road. In October 2023, Toronto City Council authorized Engineering and Construction Services to undertake this additional work. Due to the additional scope of work, the overall project is expected to be complete by Summer 2024.

We understand this project has an impact on all businesses and residents in the area surrounding St.Clair Avenue East and O'Connor Drive and we appreciate your patience during this time.

## **WORK STATUS TO DATE**

The City's contractor has:

- Completed the sewer upgrades on O'Connor Drive from Glenwood Crescent to Sandra Road and from Bermondsey Road to Dohme Avenue.
- Road reconstruction to base asphalt and sidewalk replacement on the west side of O'Connor Drive from Sandra Road to Bermondsey Road.


### **REMAINING WORK**

The remaining construction will be carried out in several phases:

- Watermain and water service replacement on O'Connor Drive from Sandra Road to Bermondsey Road.
- Road reconstruction, boulevard enhancements, sidewalk replacement and traffic signal upgrades on the east side of O'Connor Drive from Sandra Road to Bermondsey Road.
- Surface Asphalt from Glenwood Crescent to Bermondsey Road.

## WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise, increased traffic in the area and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.



**Work Hours**: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.



**Traffic Management**: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.

Traffic within the construction area will be reduced to one lane in each direction.



**Road and Sidewalk Access:** To complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.

**Driveway Access:** The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
