Road Resurfacing on Jane Street from Dundas Street West to Annette Street

Start Date: May 23, 2023, Expected End Date: September 6, 2023


NEW End Date: November 30, 2023

The City of Toronto informed residents and businesses in April 2023 that the road resurfacing project on Jane Street from Dundas Street West to Annette Street is scheduled to be completed in September 2023. Due to unforeseen signal issues encountered during construction at the intersections of Jane Street / Dundas Street West, Jane Street / St. Johns Road, and Jane Street / Baby Point Road /Annette Street, the Jane Street road resurfacing project was delayed.

This update is to inform you that construction of this project is currently underway with a planned completion date of November 30th, 2023 for all works, with the exception of the intersection work at Jane Street / Dundas Street West, which is scheduled for completion in Spring 2024. Future construction updates regarding key dates and completed work will be provided as construction progresses. Thank you for your continued patience as we complete this infrastructure project.

WORK STATUS TO DATE

The City's contractor has:

- Completed Boulevard works on both side of Jane Street, including curb, sidewalk, bus platform, driveway, and boulevard from Dundas Street West to Annette Street.
- Completed road resurfacing on Jane Street from South of Dundas & Jane intersection to North
 of Jane & St. Johns Road intersection

REMAINING WORK

- Road resurfacing on Jane Street from North of Jane Street & St. Johns Road intersection to South
 of Annette Street
- Sidewalk & Curb & Gutter construction on all three intersections
- Electrical works at Jane Street and Dundas Street West, Jane Street and St. Johns Road, and Jane Street and Baby Point Road-Annette Street signalized intersections

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise, and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.



Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.



Construction Update #2



Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.

• Traffic on Jane Street will be reduced to one lane in each direction



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.

Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



Pedestrians: The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.



Cyclists: If travelling on Jane Street and Annette Street, please share the traffic lane in the active work zones



Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.



Parking Violation Notice: If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking bylaws. If you receive a yellow notice during this construction work, do the following within 15 days of the notice date:

- 1) Contact the site inspector or person listed on the Construction Notice and give them the yellow notice number.
- 2) Dispute the parking violation notice online or in person following the process listed on the back of the parking violation notice.

You may use this construction notice as part of the explanation of why the violation should be cancelled. Please note: violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in no parking zones). In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction and may need to temporarily park on your street.



Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
