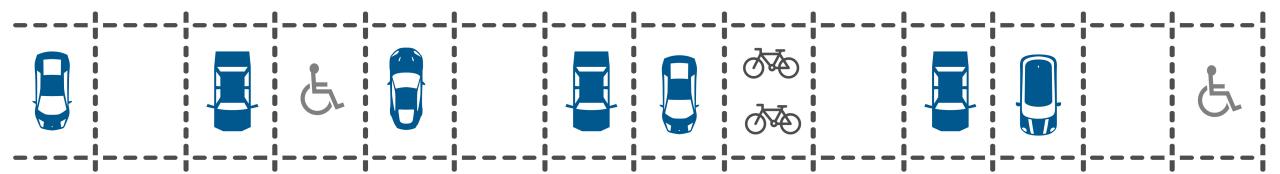

Background

- On Dec 15, 2021, Planning and Housing Committee (PH29.3) endorsed the following amendments to ZBL 569-2013:
 - Revised residential short-term bicycle parking rates in Bicycle Zone 1
 - Established a Payment-in-Lieu of Bicycle Parking program
 - Proposed requirements of bicycle maintenance facilities
- City Council directed work continue on:
 - A review of bicycle parking requirements
 - A review of City's Guidelines for the Design and Management of Bicycle Parking Facilities
 - The establishment of a parking monitoring program
 - A review of accessible parking requirements: Nov 20 (6-8pm) or Nov 21 (3-5pm)



Official Plan – Vision & Objectives

- Encourage walking, cycling and transit over other passenger transportation modes.
- Reduce dependence on private automobiles.
- Encourage cycling for everyday use
- Slow the impacts of climate change.
- Support the development of more affordable housing.



Parking Strategy Guiding Principle

Objectives:

- Support land- and cost-efficient forms of development
- \star Encourage transportation alternatives to the automobile
- Ensure sufficient parking to meet equity needs
- Allow for quick understanding and easy application



Bicycle parking zoning standards should require sufficient parking to encourage people of all ages, abilities and means to bicycle for everyday transportation, recreation and commercial activity.


Zoning By-law 569-2013: Definitions

Reg. 230.5.1.10(3):


(A) "long-term" bicycle parking spaces: <u>occupants or tenants</u>

(B) "short-term" bicycle parking spaces: visitors





Zoning By-law 569-2013: Examples






Zoning By-law 569-2013: Examples

Apartment or Mixed-Use Building (bicycle parking spaces per dwelling unit)		
	Short-term	Long-term
Zone 1	0.2	0.9
Zone 2	0.07	0.68





Directions

Ensure bicycle parking is convenient, accessible, and safe

- Reduce short-term bicycle parking area's unobstructed distance from building entrance
- Introduce bicycle-friendly path of travel and access to indoor parking spaces
- Require at least 50% of long-term bicycle parking spaces must **not** be stacked or vertical

Provide adequate space in bicycle parking areas

- Add a minimum requirement of aisle width for bicycle parking spaces
- Make at least 5% of the required long-term bicycle parking spaces as oversized spaces



Directions

Improve the end-of-trip experience to promote cycling for everyday use

- Specify the location of shower and change facilities
- Remove gender requirement and replace it with rates of universal facilities
- Require at least one universal facility for education use, schools, and hospitals

Update bicycle parking rates to provide sufficient spaces

- Increase bicycle parking rates and reclassify rates category for Apartment or Mixed-use Buildings
- Expand Payment-in-Lieu of Bicycle Parking program
- Introduce new bicycle parking rates for uses of group living
- Increase bicycle parking rates for Education Use, Schools, Office and Medical Office

Ongoing Work

- Add requirements of bicycle parking at transit stations/centres
- Minimize the gap between bicycle parking rates structure and vehicle parking rates structure
- Update Toronto Guidelines for the Design and Management of Bicycle Parking Facilities



Timeline

- Nov 2023 1st round of Public Consultation
 - Discuss the directions for proposed draft changes
 - Action: refine proposed draft changes; complete ongoing work
- Q1 2024 2nd round of Public Consultation
 - Present draft recommendations
 - Action: refine draft recommendations
- Q2 2024 Report to Council and Committee
