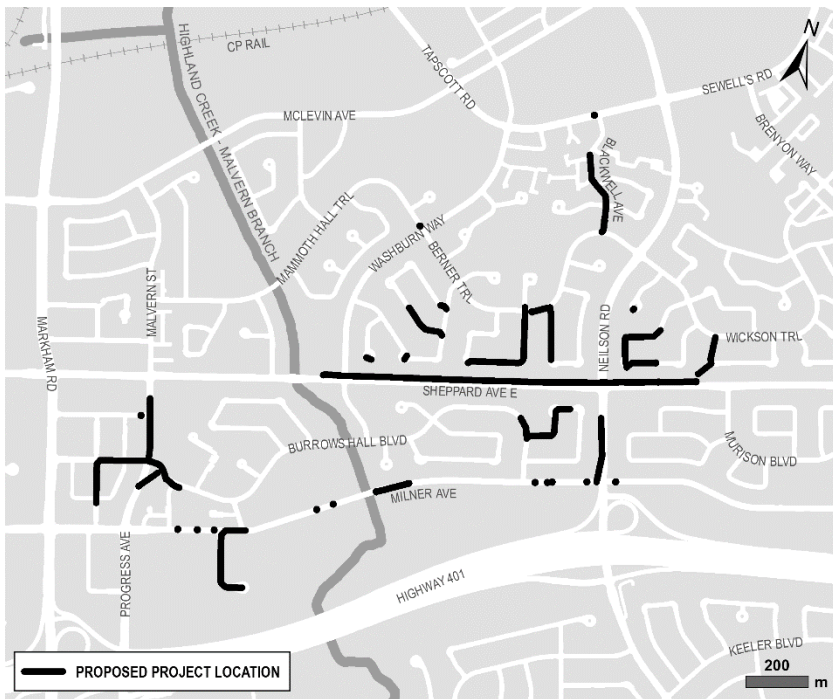


Basement Flooding Study Area 63

Municipal Class Environmental Assessment Notice of Study Completion

The City of Toronto has completed a Municipal Class Environmental Assessment (EA) study that examines surface and basement flooding within Study Area 63 and identifies improvements that can be made to city infrastructure to reduce the risk of future flooding. The study area is in north Scarborough, roughly bounded by Tapscott Road to the north, Markham Road to the west, Murison Boulevard to the east, and Highway 401 to the south. This area has experienced basement and surface flooding during severe rainstorms in the past.



Following consultation, the City is recommending:

- New and larger storm sewers,
- Sections of large diameter storm and sanitary sewers to provide storage during heavy rainfall events,
- Storm sewer upgrades through Rosebank Park,
- Curb removal to direct storm flows to Rosebank Park, and,
- Catchbasin management to reduce surface water ponding to acceptable levels during large rainfalls.

The study has been planned following the Schedule B process in the Municipal Class Environmental Assessment.
