## **DECISION:**

The Tribunal approved the request for an extension of Taxicab Owner's Licence No. V02-3605399; Taxicab Plate No. 02236 submitted by the Estate of Rod Berry to remain in the Estate until April 19, 2024.

4. Veronica Britany Zelic-Warriner (Report No. 7829) Applicant for a Body Rubber Licence (Application No. C329959)

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Body Rubber Licence be issued subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence(s) may be cancelled;
- (2) Prior to each of the next One (1) renewal(s) of the licence, VERONICA BRITANY ZELIC-WARRINER must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check;

- (3) The Body Rubber Licence will be placed on probation for a period of One (1) year(s). VERONICA BRITANY ZELIC-WARRINER is advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against VERONICA BRITANY ZELIC-WARRINER and conduct other investigations, as appropriate, to assess VERONICA BRITANY ZELIC-WARRINER's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against VERONICA BRITANY ZELIC-WARRINER or any other concerns with respect to the conduct of the licensee, those matters and report no. 7829 and any updating material, may be brought back before the Tribunal for a full hearing."
