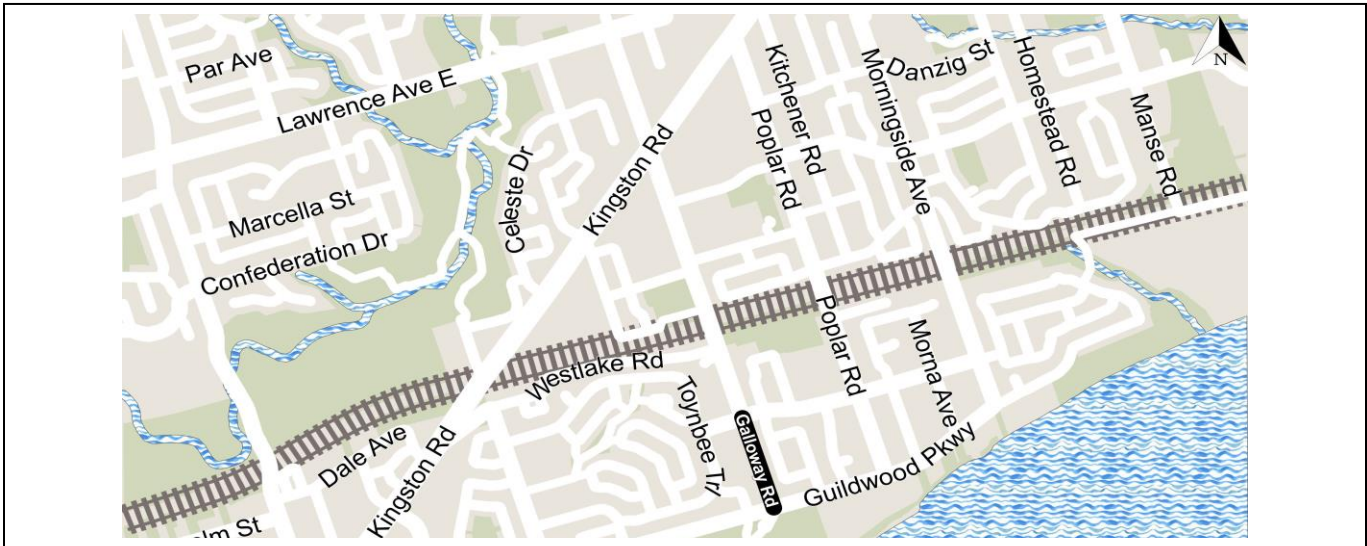
Galloway Road Sidewalk and Future Cycling Connections

Meeting Date: Monday January 15, 2024 – 7:00 p.m.
East Scarborough Boys and Girls Club – 100 Galloway Road

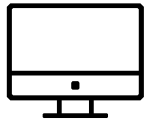
The City of Toronto is inviting residents to learn more and provide feedback on opportunities for cycling, pedestrian, motor vehicle operations, and road safety upgrades on Galloway Road, from Guildwood Road to Dearham Wood. Transportation Services was requested by City Council to review opportunities to advance the upgrade of Galloway Road from the current signed bikeway route to designated bike lanes, while exploring the installation of pedestrian infrastructure.

City staff reviewed the feasibility of traffic calming, green infrastructure, safety improvements and new bikeways. This meeting is to provide area residents with an opportunity to learn about the project, ask questions, and provide feedback.

Why Consider Changes on Galloway Road

In October 2021, City Council requested that Transportation Services explore opportunities for the installation of green pedestrian infrastructure, upgrades to the current signed bikeway to designated bike lanes and consult with the affected area residents of the Guildwood Village community.

The City of Toronto is proposing changes on Galloway Road to fulfill the City's commitment to the Vision Zero Road Safety Plan. The Plan's goal is to eliminate traffic-related fatalities and serious injuries by making our roads safer for everyone, especially for seniors, school children, and people walking and cycling.

Recommended Design

Transportation Services explored three options for installing bike lanes and pedestrian infrastructure along Galloway Road.

Option 1: Bike lanes on both sides of the street and a sidewalk on the east side

Option 2: Bike lanes on both sides of the street and sidewalks on both sides of the street

Option 3: An in-road median with bike lanes on both sides of the street and a sidewalk on the west side

Based on a detailed review of the existing conditions, Transportation Services staff recommend Option 2: Bike lanes on both sides of the street and sidewalks on both sides of the street. Option 2 is preferred as it maintains existing motor vehicle travel and provides pedestrian and cycling infrastructure on both the east and west side of Galloway Road.

Proposed Changes

- Addition of sidewalk on both east and west side of Galloway Road;
- Addition of on-street bike lanes;
- No changes to motor vehicle travel; and
- Reduced corner radii at intersections.

Next Steps

Please join City staff and the Ward 24 Office on January 15, 2024, between 7:00 and 9:00 pm to review the different design options and provide feedback on the proposed designs. There will be a short presentation at 7:15 pm and the remainder of the meeting will be drop-in format, where residents can join to speak with City staff and learn about the project. Subject to public feedback and City Council approval, installation is planned for 2025.
