



#### New development at 2306 St. Clair Avenue W


There will be a new 10-storey mixed-use building development at 2306 St. Clair Ave. W.

Funding from this development (Section 37) will be used to improve the local neighbourhood in walking distance from the new building.

# Section 37 is an essential tool for helping to build healthier neighbourhoods.

- To be used towards local improvements within the vicinity of the site, including parks, streetscape, cycling and pedestrian safety improvements.
- Zoning bylaws control how the land in your neighbourhood is used, including the height and density of buildings.
- When a developer wants to build something that exceeds these limitations, Section 37 of Ontario's Planning Act allows the City to permit the developer's proposed construction, in return for community benefits (cash-in-lieu or in-kind contributions) that help to improve the neighbourhood the development is located in.
- Section 37 benefits are used for a variety of local improvements that meet the needs of the community!

# **HOW** should these funds be used to improve the local St. Clair West neighbourhood near the new development?



**Park improvements** (e.g. playground, splash pad, shade structure, basketball, tennis/pickle ball, seating)



Streetscape improvements (e.g. curb cuts)



**Cycling safety** 



**Pedestrian safety** (e.g. park pathways, missing sidewalks, marked/improved crossing)

#### Idea Ranking





632 comments in the study area
249 comments related to parks
229 comments related to transportation
471 up-votes on comments in the study area



## **Transportation-Related Feedback**

We received over **227 transportation-related** comments through Social Pinpoint!

- These comments ranged from Pedestrian Experience, Streetscape, Lighting, and Cycling Safety and Infrastructure improvements!
- These comments were spread evenly throughout the study area.

#### What we heard:

- Need for more pedestrian and cycling connectivity (sidewalks, bike lanes, curb cuts, bridges)
- Pedestrian and cycling safety (dedicated space, crosswalks, slowing/stopping vehicles, path lighting)

We are passing on all transportation-related feedback to the City's Transportation Services department, and will include these ideas in the ranking exercise next week.















## Planned Cycling Safety & Infrastructure Improvements

#### Types of improvements that can be expected with planned roadwork:

- Curb extensions
- Curb radii reductions
- Intersection normalization: reconfigure an irregular (skewed/offset) intersection
- Missing sidewalks (or widening of existing sidewalks to current standards)
- Raised crossings near schools
- Improvements to accessibility


