# **Project Summary**



#### **Project Background**

- The F.G. Gardiner Expressway has been in service for more than 60 years.
- Due to the impacts of weather, salt and increasing traffic loads, it is approaching the end of its original service life.
- The implementation approach for the Strategic Rehabilitation Plan, consisting of six complex projects, was adopted by Toronto City Council in 2016.
- Section 1 construction work was completed in 2021.
- The section of Gardiner Expressway between Dufferin Street and Strachan Avenue (Section 2) is nearing the end of its service life and is now an urgent priority for rehabilitation.

### Gardiner Rehabilitation: Dufferin Street to Strachan Avenue





### **Project Scope and Status**

- Includes replacing 700 metres of the structural elements (girders and concrete deck) that hold up the road surface and rehabilitating all the structures underneath that support it.
- A Design-Build contract was awarded to Grascan Construction Limited for this project.
- Design-Build is a project delivery and management approach where the contractor takes on more responsibility for the design phase with the goal of speeding up construction and encouraging innovation.
- In December 2023, City Council approved the Term Sheet of the Ontario-Toronto New Deal Agreement, a package of provincial supports to assist the City with its long-term financial plan.
- Within the listing of provincial supports, the capital and operating costs of the Gardiner Expressway and Don Valley Parkway are to be uploaded, subject to third-party due diligence, which is targeted to be completed by the end of 2024.





#### **Construction Schedule**

- Overview of the anticipated schedule:
  - Fall 2023: Mobilization to the site laydown area and prep work on the underside of the Gardiner Expressway.
  - **Spring 2024:** Lane restrictions will be implemented on the Gardiner Expressway deck, and construction activities involving more intensive, noisy operations will start.
    - All lanes will be open for FIFA World Cup 2026 (May to end of July)
  - Mid-2027: Expected end.



#### **Travel Impacts**

- The Gardiner Expressway will be reduced to two lanes in each direction between Dufferin Street and Strachan Avenue, with intermittent, additional lane reductions as required.
- The eastbound on-ramp to the Gardiner Expressway from Lake Shore Boulevard east of Jameson Avenue will be closed during construction to help mitigate traffic merging and congestion approaching the work zone.
- Motorists are encouraged to plan their travel and consider public transit.



#### **Pedestrian Access**

- Walkway on Manitoba Drive and through Exhibition GO station connecting Atlantic Avenue to Manitoba Drive will remain open.
- It may require occasional closure for overhead work, which will usually occur at night when GO trains are not running.
- Signage will be posted.



#### **Transit Impacts**

The city is also working with the following transit agencies to minimize impacts: TTC

- The project team is coordinating with the TTC and the contractor to find construction methods that will cause the least disruption to TTC services.
- Updates will be provided throughout construction.

Metrolinx

- Pedestrian access at the Exhibition GO Station will be maintained during construction while GO trains are in service and during major events.
- Overhead work above the pedestrian access tunnel will only take place overnight while GO trains are not in service. Close coordination will occur with Metrolinx.



#### Work Hours

- Construction will mainly occur from 7 a.m. to 11 p.m., Monday to Saturday, with occasional Sunday work.
- The schedule may vary depending on the nature of the work.
- Some activities may happen overnight to minimize disruptions over Exhibition Go Station.
- When overnight work is required in areas such as Exhibition GO station, noise levels are expected to be lesser or similar to daytime construction activities.



### Noise

The City is making efforts to reduce noise impacts by:

- Conducting the noisiest activities during daytime hours.
- Installing noise monitors in the neighbourhood to assess construction-related sounds and address when necessary.

When overnight work is required in areas such as the Exhibition GO station, noise levels are expected to be similar to daytime construction activities.





#### **Project Coordination**

Gardiner Section 2 Rehabilitation will be coordinated with other construction work in the area:

King Street West Watermain and TTC Track Replacement Work

- The City of Toronto and the Toronto Transit Commission is renewing the aging streetcar tracks on King Street West between Dufferin Street and Shaw Street in 2024. The City will also replace the 146-year-old watermain on King Street between Dufferin Street and Shaw Street.

Local Road Resurfacing – Fraser Avenue

 Sanitary sewer replacement and road resurfacing are planned at the intersection of Fraser Avenue and Liberty Street as well as 100m south along Fraser Avenue from the intersection. This project will proceed once work on King Street West is completed in this area.



### **Tools to Manage Traffic**

To help manage traffic flow during construction, the City will undertake the following measures:

- Traffic Signal Timing Adjustments
- Signage Plan
- Camera Observations
- Travel Time Data
- No "Fly" Zone





### **Construction Phasing**

Gardiner Section 2 (Dufferin Street to Strachan Ave) & King Street Construction (Dufferin Street to Shaw Street)





## Signage Plan

- Portable Variable Message Units (PVMS), Variable Message Signs (VMS) and static signage to be installed two weeks prior to construction
- 25 PVMS and 80 static signs for Gardiner Section 2
- 5 VMS on Gardiner/DVP
- 3 PVMS and over 33 static signs for King St Construction

### **Camera Observations**

- Critical camera locations to be monitored at the highlighted locations
- Camera observations during both pre and on-going construction periods, to determine locations most impacted by construction activities where further mitigation measures may be beneficial
- Assessment of new camera installations being conducted:

**TORONTO** 

- Dundas St W and Dufferin St
- Dundas St W and Bathurst St Lake Shore Blvd and British Columbia Rd



## **Signal Timing Adjustments**

- Traffic signal timing adjustments planned within the following boundaries:
  - Dundas St W to the north
  - Bathurst St to the east
  - Lake Shore Blvd to the south
  - Roncesvalles Ave to the west
- Further timing adjustments (within and outside the boundaries) may be applied throughout the project based on; other construction activities, special events, on-going staff monitoring/observations and public feedback



### **Travel Time Data**

- Travel time data to be collected and monitored on the following roadways:
  - College St
  - Dundas St W
  - Queen St W
  - King St W

**TORNNTN** 

- Lake Shore Blvd W
- New travel time data collected on a weekly basis; data will be analyzed to determine hot spots and assess the need for further traffic mitigation measures (i.e., signal timing adjustments, PVMS deployment, traffic agent deployment)



### No Non-Emergency Street Occupations

- Non-emergency utility/street occupations on major arterials temporarily suspended during CNE (August 16 – September 2), within Zone A
- Zone B in effect during games/ venues at Rogers Centre and Scotia Bank Arena

Boundaries :

- A Queen St to the north, Spadina Ave to the east, Lake to the south
- B Front St W to the north, Bay St to the east, Queens Quay to the south, Spadina Ave to the west
