
### Road Resurfacing on Jane Street from Dundas Street West to Annette Street

Contract: 22ECS-TI-13MR Start Date: April 2024, Expected End Date: June 2024 \*Timeline is subject to change.

The City of Toronto informed residents and businesses in October 2023 that the road resurfacing project on Jane Street from Dundas Street West to Annette Street is scheduled to be completed in November 2023. All works have been completed from Dundas Street West to Annette Street, except for the intersection at Jane Street and Dundas Street West. Delays in completing the work at this intersection were caused by unforeseen signal issues encountered during construction.

This update is to inform you that construction of the intersection work at Jane Street and Dundas Street West is set to begin April and scheduled for completion in June 2024. Future construction updates regarding key dates and completed work will be provided as construction progresses. Thank you for your continued patience as we complete this infrastructure project.

#### WORK STATUS TO DATE

The City's contractor has:

- Completed Boulevard works on both side of Jane Street, including curb, sidewalk, bus platform, driveway, and boulevard from Dundas Street West to Annette Street.
- Completed road resurfacing on Jane Street from South of Dundas & Jane intersection to Annette Street

#### **REMAINING WORK**

- Road resurfacing works on Jane Street and Dundas Street West intersection.
- Sidewalk & Curb & Gutter construction in this intersection.
- Electrical works at Jane Street and Dundas Street West signalized intersection.

#### WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.

# **Construction Update 3**

÷	<b>Road and Sidewalk Access:</b> In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.
	<b>Driveway Access:</b> The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.
∽	<b>Pedestrians:</b> The work may require temporary sidewalk restrictions, however any necessary sidewalk closures will alternate in each direction to ensure pedestrian access is maintained during construction.
GTO	<b>People Cycling:</b> If travelling on Jane Street and Annette Street, please share the traffic lane in the active work zones
$\mathbf{R}$	<b>Parking:</b> This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.
	<b>Parking Violation Notice</b> : <u>Please ensure you park in a legal parking spot at all</u> <u>times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:
	<ol> <li>Pay the parking violation (follow instructions on the back of the notice) <u>or</u></li> <li>File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.</li> </ol>
	If you do not have a copy of the Construction Notice, please contact 311 to request a copy.
	<b>Please note</b> : Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in No Parking zones).
	In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
Ġ	Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
