Road Resurfacing on Bayview Avenue from Roehampton Avenue to 30 m North of Armistice Drive

Contract: 23ECS-RD-04MR
Start Date: April 2024 End Date: September 2024
*Timeline is subject to change.

In May 2023, the City notified residents of this planned work, however due to delays encountered with the tender and award process the work was deferred to Spring 2024.


The City of Toronto is planning to resurface Bayview Avenue from Roehampton Avenue to 30 m north of Armistice Drive. Our inspection of the road shows that it needs repaving, and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair. The City will also perform traffic signal upgrades at all Bayview Avenue signalized intersection within project limits.

Additionally, pedestrian improvements are planned at several intersections, including Roehampton Avenue, Craig Crescent, Glazebrook Avenue, Broadway Avenue, Glenvale Boulevard, Sunnydene Crescent, Blythwood Road/Wellness Way, Hargrave Lane/Armistice Drive. The pedestrian improvements at these intersections involve the installation of tactile walking surface indicators, curb radii reduction, and re-alignment of crosswalks.

Improvements to the roadway includes closure of all bus lay byes within the project limits except the lay byes north of Kilgour Road and installation of median islands at 120 m north of Kilgour Road.

This project is part of the Council-approved 2023 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

The City's contractor will:

- Dig up the road surface
- · Re-align maintenance holes and catch basins
- · Repair curbs and gutters
- Repave the road surface

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- The City will not be responsible for damage to any privately owned items on City property.



Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.



Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.

This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the **Project Contact** listed below.





Telephone and Internet Services: This work may affect phone and internet cables for individual properties that aren't buried deep below the sidewalk. The contractor will coordinate with utility companies to minimize disruption. Residents who find their service has been disrupted should contact the **Project Contact** <u>and</u> notify their phone or internet service provider.



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the work zone. Access for emergency vehicles will be maintained at all times.

Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



Traffic Management: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.

Traffic on Bayview Avenue will be reduced to one lane.



On-Site Communication: There are times when contractors need to communicate with homeowners about what is happening on-site. This could be about driveway access, water shut offs, pre-construction inspections, and site restoration work (landscaping, installing pavers etc.). Contractor's staff will be identifiable by their high-visibility company branded clothing. If you need to speak with staff on the construction site, please ask for the Site Inspector.



Parking: This project will affect on-street parking. Parking in the active work zone is not permitted as space is needed for construction equipment and materials. If your parked vehicle affects construction work, it will be relocated with no charge to the owner. Please call 416-808-2222 for its location.



Parking Violation Notices: <u>Please ensure you park in a legal parking spot at all times.</u> If parking enforcement is called to a street, officers must issue a yellow parking violation notice (ticket) to vehicles in violation of parking by-laws. If you receive a yellow notice during this construction work, please do one of the following within 15 days of the notice date to avoid additional fines or records being kept of non-payment:

- 1. Pay the parking violation (follow instructions on the back of the notice) or
- 2. File a Parking Violation Dispute with the City online, by mail, or in person (follow instructions on the back of the notice). As part of the dispute process, you may include the construction notice and/or other documentation related to parking impacts resulting from construction.

If you do not have a copy of the Construction Notice, please contact 311 to request a copy.
Please note : Violation notices cannot be cancelled if vehicles are parked in illegal parking spots (i.e. in front of a fire hydrant or in No Parking zones).
In an effort to reduce ticketing due to construction, please exercise patience with neighbours who are experiencing construction impacts and may need to temporarily park on your street.
Garbage and Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. <i>Please</i> ensure that you label your bins with your address.
Restoration: The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
