1.0 Introduction

1.1 Project Background

A new Community Recreation Centre (CRC) is coming to the Don Mills community, near the intersection of Eglinton Avenue East and Don Mills Road.

This large, integrated, and multi-component facility will offer the diverse and growing communities of the Don Mills Corridor and beyond a range of year-round programs and services. Located at the former Celestica Lands site at 844 Don Mills Rd., the new CRC will be next to a new large park and all within walking distance of a planned Eglinton Crosstown Light Rail Transit (ECLRT) station and is part of the ongoing implementation of the <u>Parks and Recreation Facilities Master Plan</u>.

1.2 Project Context

Previous Community Engagement: Recreate Don Mills

In early 2019, community and stakeholder engagements were conducted to determine the CRC location that would best meet community needs. Two location options were presented to the community.

The results indicated that locating a large 'one-stop' community recreation centre with arena, aquatics facilities, full gymnasium and multipurpose room uses at the former Celestica Lands (844 Don Mills Road) was preferable to two separate facilities.

Based on the outcomes of the 2019 community engagement and recommendations by City staff, City Council directed the City to <u>proceed with the Preferred Facility</u> on the former Celestica Lands site.

The community engagement and design process for the Don Mills CRC will consider only the amenities, programs and services within the CRC located on the former Celestica Lands. Separate community engagement processes will be held for the design and programming of the one-hectare park next to the Don Mills CRC.

1.3 Project Timeline

The anticipated schedule for this park project is as follows:

- Fall 2021 Hire a design team
- Winter 2022 Community engagement process starts
 - December 2022 April 2023: Community Engagement Phase 1: Building a Vision
 - Spring Summer 2023: Community Engagement Phase 2: Exploring Design Options
 - Fall 2023 Winter 2023/2024: Community Engagement Phase 3: Setting the Direction
- Winter 2023/2024 Detailed design
- Spring 2026 Hire a construction team
- Summer 2027 Construction starts
- Winter 2030 Construction complete, Community Recreation Centre opens

The timeline is subject to change.



1.4 Phase 2 Engagement Activities

This phase of engagement is separated into two parts, A and B. During Phase 2a, feedback will be collected on early drafts of the design options. In Phase 2b, feedback will be collected on refined versions of the draft design options based on what the project team heard during Phase 2a.

During this phase of the community engagement process, the City and the design consultant will work off of the outcomes of Phase 1 to develop two design options for the Community Recreation Centre (CRC). These will be presented to the community for feedback, with input collected used to develop a preferred design for the CRC.

At the end of Phase 2, a preferred design option will be selected by community members, and design consultants will begin working on a final design for Phase 3: Setting the Direction.



2.0 Community Advisory Committee Meeting Summaries

This document provides a summary of the second virtual Public Meeting for the Don Mills Community Recreation Centre project held in Fall 2023. The summary of feedback is provided in Section 3.0.

2.1 Public Meeting #2

A second Public Meeting for the Don Mills CRC project was held virtually on Tuesday, November 7th, 2023 from 6:00 p.m. to 8:00 p.m.

- 2. Present the Design Concept Options
- 3. Provide an opportunity for members of the public to ask the Project Team questions and provide feedback on the Design Concept Options
- 4. Next Steps



3.0 What We Heard

The following section contains a summary of the feedback received during the Phase 2 virtual Public Meeting.

3.1 Key Insights

Three key insights that have emerged from the Public Meeting are consolidated below.

MORE DETAIL REQUIRED

Throughout the meeting, participants consistently asked questions about the specifics of the Don Mills CRC, such as the length and depth of the lap pool, locations of washrooms and elevators, and provision of seating and viewing spaces. Some of the participants' questions were unable to be answered by members of the Project Team, as they were yet to be determined.

The current design iteration for the CRC did not seem satisfactory and did not provide members of the public with enough information to be satisfied with the CRC or to begin to generate more fulsome ideas around programming and amenities they wish to see included.

FOCUS ON ACTIVE RECREATION AND FITNESS SPACES

While members of the CAC and Youth Ambassadors expressed that they wish to see more multi-purpose and community-oriented spaces be integrated into the design of the Don Mills CRC, rather than some of the active recreation and fitness-oriented spaces, participants of the public meeting were keen to talk about these spaces, especially the aquatics facilities, walking / running track, and twin ice pad arenas.

This confirms that, while the active recreation spaces are not top-of-mind for all members of the community, there is still significant interest in these spaces.

CONCERNS AROUND PARKING AND TIMELINES

Participants of the public meeting echoed CAC members' concerns around the amount of parking being proposed for the Don Mills CRC. Participants were notified at the beginning of the meeting that we had heard concerns around parking and that the City of Toronto will be looking into options; however, concerns continued to be raised.

Meeting participants expressed additional recommendations around parking including security, monitoring use by non-CRC users, and the inclusion of bike storage and electric vehicle charging.

Concerns about changes to the project timeline were raised during this meeting, with participants wondering how the project could be sped up to see the CRC realized sooner.



3.2 Public Meeting #2 Summary

The following section provides a summary of participants' responses to questions integrated throughout the presentation on the virtual tool, Mentimeter. A summary of comments and questions provided by participants throughout the virtual meeting (verbally or in the chat) is provided in Section 3.2.2.

3.2.1 Responses to Mentimeter Questions

Throughout the presentation, participants were invited to respond to questions on their phones or computers about the design or programming elements they wish to see included or changed. Participants who were unable to participate using the tool were invited to share their feedback in the chat.

To ensure that participants felt comfortable using the tool, and to gather information on participants' interests and identities, participants were asked the following question:

Which of the following best describes you? (29 respondents)

Participants could select as many responses that apply to them.

- I live nearby 28 responses
- I work nearby 11 responses
- I play (shop, visit parks) nearby 18 responses
- I participate in sports nearby 12 responses
- I attend school nearby 1 response
- I visit faith spaces nearby 7 responses
- I am a parent 9 responses
- I am an Indigenous community member 1 responses

Following the presentation of the main floor plan, participants were asked:

After seeing the main floor plans, which of the following spaces are you most excited about? (29 respondents)

Participants were asked to select one response representing the space they are most excited about.





It is worth noting that responses to this question varied quite significantly from previous engagement activities, where participants were more interested in speaking about the multipurpose and community-oriented spaces and programs. This confirms that, while the twin ice pads and aquatics facilities are not top-of-mind for all members of the community, there is still significant interest in these spaces.

Participants were then shown precedent (example) images of the smaller multi-purpose rooms and the community hall and kitchen, with accompanying square footage and occupancy limits.

The following question was:

Which types of features, activities and programming do you think the community hall and multi-purpose rooms should have or accommodate? (16 respondents)

Responses included:

- Fitness classes (4)
 - Women's fitness (1)
 - Seniors' fitness (1)
 - Yoga for seniors (1)
- Arts and crafts (2)
 - Music (1)
- Ability to rent rooms (2)
- Health and wellness activities and education (2)
- Cooking classes (1)

 - Technology classes (1)
- Party room (1)
- Game room (1)
- Social clubs (1)
 - Book clubs (1)
- Flexible, multi-use space (1)
- Preference for rooms to allow for large community meetings (1)

Participants were shown precedent images for the lobby and common areas, and asked to respond to a similar question to the above.

Which types of features, activities and programming do you think the lobby and common areas should have or accommodate? (12 respondents)

Responses included:

- Snack bar / coffee bar (3)
- Charging stations (2)
- Plenty of seating options (4)
- Community library / book swap (1)
- Clothing swap (1)
- Toy swap (1)
- Equipment rental (1)
- Water fountain (1)
- Embrace diversity (1)
- "Meet and Greet" for seniors [social program] (1)
- Indoor bicycle storage (1)



• Storage areas for community sports clubs (1)

The Project Team presented the plans for the second floor of the Don Mills CRC, and then asked:

After seeing the second floor plans, which of the following spaces are you most excited about? (26 responses)

Participants were asked to select one response representing the space they are most excited about.

Again, the preferred space identified in this question differs quite significantly from conversations with the Community Advisory Committee and Youth Ambassadors in Phase 2 of the project. These groups did not discuss the walking / running track in much detail, with a preference to focus on the community-oriented spaces, suggesting that attendees of the Public Meeting represent different user groups than those captured in other engagement activities.



Participants were shown precedent images of the double gymnasium and fitness studios, with accompanying square footage and occupancy limits, and were asked:

Which types of features, activities and programming do you think the fitness studios and double gymnasium should have or accommodate? (1 respondent)

• Fitness classes (1)

Finally, participants were presented with an overview of the Civic Colonnade design concept, precedent images and section diagrams, then asked:

Is there anything that you would like to see considered in the design of the civic colonnade? (5 respondents)

- Preference for modern design (1)
- Preference for a less obstructive design (1)
- Concerns about accessibility (1)
- Find the design concept impressive (1)
- Concerns about blocking natural light (1)
- Would like water fountains in the public realm (1)



- Natural paintings (1)
- Canadian flag (1)

3.2.2 Summary of Participant Comments and Questions

The following section provides a summary of more detailed comments provided by participants in Public Meeting #2, listed by category.

Aquatics Facilities

- Questions about the size and depth of the lap pool were addressed by the Project Team.
 - The project team specified that the pool would be 25m long, 6 lanes wide, and the depth and other amenities had not yet been confirmed.
- A couple of participants wondered how many individual changing stalls would be included in the universal change rooms. This question was addressed (the number is to be confirmed based on available space) and prompted follow-up comments:
 - One participant felt that there were not enough stalls to accommodate the number of people that might use the facility at one time.
 - One participant raised concerns about the inclusion of a universal change room, as well as shower facilities that open up onto the pool deck, citing negative experiences at other City of Toronto aquatics facilities that had universal change rooms.
 - Participants mentioned community centres and pools, such as Ethennonnhawahstihnen, Douglas Snow, Cummer, Agincourt (indoor), or Parkway Forest (outdoor) as examples of change room facilities that make them feel safe and comfortable.
- A couple of participants identified that there did not seem to be much or enough viewing space / seating areas for the aquatics facilities.
- Comment was made around the addition of two pools (leisure pool and lap pool), since there are other pools in the community.
 - A conversation occurred in the chat between two participants. One participant rebutted that the area is about to become highly populated and two pools would support the growing population. The original commented mentioned that new condominiums often include their own pools and gym facilities, but the other participant disagreed, citing the certain apartments / condos at Shops at Don Mills as an example.
- One participant suggested that the pool could open out onto the park, so that the pool effectively becomes an outdoor swimming pool in the summer.
 - The Project Team explained the complexities of this including maintaining temperature and humidity levels in the pool space, and challenges with fitting all proposed amenities in the site plan, should the location of the pool be altered.



• One participant suggested that the pool should be rented for swimming organizations to bring in additional revenue.

Twin Ice Pad Arenas

- A couple of participants identified that there may not be enough viewing space / seating areas for the twin ice pad arenas.
- A couple of participants asked if one of the ice pads could be converted to a "dry pad" for the hockey off-season to be used for ball hockey or indoor soccer. Several participants agreed that this would be a preferred use.
 - Some participants mentioned that indoor soccer during winter would be appreciated.

Community Hall and Kitchen

- One participant felt that the tentative occupancy for 175 people (seated) would not be enough for a community meeting.
- One participant suggested that a theatre, performance hall and/or concerts be included in the community hall.
- One participant suggested several seniors-focused programming for the community hall, including book clubs, gentle exercise, card games like bridge or euchre, lectures and cognitive programs.

Lobby and Common Areas

- Several participants had questions about the locations of public washrooms, change rooms, team rooms, elevators, stairs, viewing areas and more.
 - The Project Team walked participants through the site plan in more depth to answer any questions about locations / features of these amenities.
- Several participants mentioned that having a community coffee shop would be a great amenity in the lobby.
- One participant mentioned concerns around noise in the lobby due to hockey games and amount of open, linear space.
- Places to charge phones

Fitness Spaces

- A couple of participants expressed concerns about people having to cross over the walking / running track to access amenities on the second floor (concerns about collisions).
 - An additional concern was equipment from the open fitness area rolling onto the track and presenting a hazard for walkers / runners.



- One participant presented an idea to raise the walking / running track to a third level, which would overlook the gym spaces, and many participants appreciated this alternative.
 - The Project Team addressed this idea, citing challenges of cost and logistics, but noted that they would look into this as an option.
- One participant expressed their perspective that walking / running tracks in existing CRCs in the city are often used as "viewing spaces" by the general public, which creates conflict with people trying to use the track.

Parking and Traffic

- A couple of participants wondered whether there would be free or paid parking at the Don Mills CRC, with one citing the \$5/hour parking at Ethennonnhawahstihnen Community Centre.
- One participant suggested that the parking garage be monitored to ensure it is only used by users of the CRC, and to prevent people from parking at the CRC in order to take transit (LRT).
 - Another person mentioned that there should be monitoring for safety reasons.
- A couple of participants requested that secure bicycle parking (e.g., cages) be provided.
- One participant requested that electric vehicle charging stations be included in the parking garage.
- One participant requested that there be a drop off lane in front of the CRC for people (especially seniors) to be dropped off.

Civic Colonnade

- One participant suggested that a large screen could be integrated into the colonnade so that movies could be played in the park / CRC public realm in the summer months. Several participants agreed that this would be a preferred use.
- One participant suggested that the colonnade could recognize the athletes named on the new streets in the community.

Sustainability

- A couple of participants mentioned sustainability amenities such as solar panels, EV charging, and community gardens.
- A couple of participants expressed that they appreciated the commitment to net zero carbon.

Timelines

• A couple of participants expressed dissatisfaction that the project had been delayed and wondered what could be done to speed up the process.

Miscellaneous



- One participant mentioned that it would be beneficial if youth employment was encouraged at the Don Mills CRC.
- One participant asked that the Don Mills CRC be dedicated to and serve as a tribute to the Don Mills Community, where residents have been waiting for a new community centre for decades. In addition, the CRC could acknowledge the fact that Don Mills is Canada's first planned community.

3.2.3 Responses from the Project Team

This section contains responses to participants' questions that were unable to be answered fully during the public meeting.

- Why was the project delayed?
- What can members of the public do to advance the project timeline?
- What are the hours of the Don Mills CRC?
- Given that community centres are often used as a space for refuge in case of emergencies, will there be any particular provisions made for the Don Mills CRC?
- How will the additional traffic coming to and from the Don Mills CRC be managed?
- Who will manage security inside the Don Mills CRC?
- Will parking provided in the underground parking garage be paid or free?
- Could infrastructure on the roof be included for a community garden and/or solar panels?
- Is there any potential to heat the pool and the rest of the building using a geothermal heating system?
- Will there only be a universal change room or will there be an option for gendered change rooms?
- Will there be a daycare included in the Don Mills CRC?
- Will the track have slightly banked corners to reduce risk of ankle/knee injuries?
- Will both of the ice pads be operating in summer?
- How will the permitting of the rink work?
- How will storage requirements, office space, etc. be managed for organizations using the twin ice pads?
- Will there be a skate sharpening facility?
- Will the Don Mills Civitan Hockey Association be relocating to the new arenas?



4.0 Next Steps

The feedback received in Phase 2 of community engagement will be used to refine the design of the Don Mills Community Recreation Centre. An updated design will be shared with the public in community engagement Phase 3: Preferred Option.

- Question A) Why has this project opening date been delayed into the 2030s? B) What can we do to bring this project back to original completion date of 5 years from now in 2027?
- This project doesn't appear to be a priority for the city as it keeps getting delayed, we need shovels in the ground asap.
- C) why is this project not a serious priority for the city?
- Thank you!
- Thank you Councillor Burnside, your voice and dedication to push this project forward is appreciated.
- Hello all, thank you for this presentation. It's fantastic to see that the City is building additional swimming pool space.
- My question is what the City plans to do with the leased facilities that they currently hold in agreement with the TDSB. Many of those pools sit empty throughout the year.
- Does "universal change room" mean that the decision has already been made that there will ONLY be a universal change room? No further discussion about having a separate women-only change room?
- Not sure about 2 pools given there is a pool currently at the Community Centre at St Dennis and Deauville.
- What happened to the plan for a running track?
- 2 pools would be great, this area will become heavily populated. Over 70 high rise condos proposed / built between Eglinton and bayview and Eglinton and warden. Ontario Line and Eglinton LRT will (hopefully) be open before the community Centre is bringing in lots of people.
- Could we see infrastructure on the roof for a community garden and/or solar paneling for sustainability themes
- Good points but Condos generally come with their own pools and gyms
- How will the additional traffic coming to/from the Centre be managed? The area is already jammed with traffic and the intersection of Don Mills and Eglinton is chaotic.
- AH, not really. The apartments at the SHOPS don't have any pools; they were expecting pool availability at the original Community Centre that was planned for the SHOPS
- None of the aspens ridge development at the celestica site (16 high rise towers and hundreds of towns) dont have any pools being built
- given the vast surrounding parkland one would think the space wouldn't have to sacrifice facilities for parkland - the pool spaces seem to be smaller than originally planned - making way for all that the 2 NHL sized arenas need - they would need snack bar(s) - didn't see if they were in the plans... etc...
- Also with the Ontario line and Eglinton Irt, it may be easier to get to this community Centre instead of another community Centre which May be closer from a distance perspective - have to keep that in mind too
