Anchor Agency Services & Supports - Call for Applications Building Profile and Site-Specific Addenda and FAQ #1

1. Buildings were selected by the City of Toronto ("the City"), in partnership with a housing provider partner(s). Who is/are the housing provider(s)?

The housing provider for all three (3) site locations is Toronto Community Housing Corporation (TCHC).

2. What are the addresses for each TCHC site location?

This site consists of 2 buildings, with a total of 720 units (631 bachelor units and 89 one-bedroom units).

5. How many Indigenous youth living at each building site are between 16-29 years old?

6. How will the service delivery requirements support Black and Indigenous tenants living at these addresses?

Organizations applying to the Anchor Agency Services & Supports Funding Call must provide culturally responsive approaches to the tenants residing in each building including Indigenous and Black tenants.

That said, The Anchor Agency Services & Supports program model does not apply to a specific target group. The services and supports under this program model are intended to support all eligible households in the building.

7. Are Francophone organizations eligible to apply?

Any organization that meets the <u>mandatory eligibility requirements</u> can apply to the Anchor Agency Services & Supports Funding Call.

Francophone organizations are welcome to apply, however, it is important to note that the service model does not apply to a specific target group. If awarded, organizations that serve a specific target group will also be required to support all eligible tenants in the building(s) and the broad community.

8. Will office space be available for the successful organization(s) to work in?

Yes, TCHC will be supplying space for the successful organization(s) to work at for all 3 sites. Space will include an office space and a recreational space.





9. Will building tours be offered to successful organization(s)?

No, building tours will not be provided to successful organization(s).

10. Will the successful organization(s) be required to provide property management and maintenance support?

No, the successful organization(s) will not be required to provide property management and maintenance support.

11. When evaluating applications, will organizations that are located within the wards of the building sites/addresses be prioritized over organizations that are not located within the ward of an identified building site?

No, the organization's location/address will not be prioritized if they are located within the wards of the identified buildings. However, knowledge of the community and clientele of the site locations will be beneficial for the successful organization(s) and should be reflected in the narrative section of the TGRIP application.

12. Can an organization apply to support multiple site locations? Or, is the City looking to fund one organization per site location?

Organizations applying are expected to identify which building site(s) they would like to support. Organizations can apply to support one, two or all three site locations.
