
# TEMPORARY ROAD CLOSURE: Harlock Boulevard at Almore Avenue

Contract: 21ECS-LU-10FP
Expected Start Date: Monday, April 1, 2024
Expected End Date: Monday, September 30, 2024

Timeline is subject to change.

The City of Toronto is modifying and upgrading the storm and sanitary sewer system in your area to reduce surface and basement flooding. Due to the nature of the sanitary sewer construction work, access to Almore Avenue from Harlock Boulevard will be closed. This temporary road closure will occur on April 1, 2024, until September 30, 2024. This project is part of the Council-approved 2023 Basement Flooding Protection Program to improve the water distribution system, renew our aging infrastructure and reduce the risk of sewer collapse or blockages that cause sewer backups and flooding.

#### **WORK DETAILS**

For this project, the contractor will be:

- modifying and upgrading the storm and sanitary sewer system in your area to reduce surface and basement flooding.
- replacing the city-owned portion of substandard water services and sanitary sewer laterals

#### WHAT TO EXPECT DURING CONSTRUCTION

- The community will experience dust, noise and traffic delays.
- The city will make efforts to reduce impacts. Your patience is appreciated.



**Traffic Management**: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.



**Physical Distancing:** There are times when contractors need to communicate with homeowners about what is happening on-site. Contractor's staff will be identifiable by their high-visibility clothing and will maintain physical distancing.



**Pedestrians:** The existing sidewalk will be maintained, and construction work won't impose any temporary sidewalk restrictions.



Work Hours: Work will take place from 7 a.m. to 7 p.m., from Monday to Friday.



**Accessible Accommodation:** The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the Field Ambassador listed below.
