TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: May 9, 2024 (9:30 AM) Summary of Decisions V. Francis

1. El Tren Latino Inc. (Report No. 7901)

o/a El Tren Latino Nelson Giovanni Sarria, Director Applicant for an Eating Establishment Licence (Application No. C349200)

DECISION:

The Tribunal approved the request for adjournment to August 15, 2024 at 9:30 a.m.

El Tren Latino Inc., Nelson Giovanni Sarria, Director filed a request for adjournment of this matter with the Toronto Licensing Tribunal via email and Municipal Licensing and Standards agreed to the adjournment request.

The Hearing Chair further stated on the record, matters before the administrative Tribunal and the Courts are to be taken seriously. Furthermore, the Chair commented: "This is not the way we operate and if he's applying for a licence, this is not the cavalier attitude that he should take towards anything to do with."

2. Ata Muhamad Khawaja (Report No. 7922)

Applicant for a Retail Store (Food) Licence (Application No. C421543)

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

"Retail Store (Food) Licence will be issued, subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled: May 9, 2024

- (2) Immediately upon being issued, the Retail Store (Food) Licence will be placed on probation for a period of Two (2) years. ATA MUHAMAD KHAWAJA is advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against ATA MUHAMAD KHAWAJA and conduct other investigations, as appropriate, to assess ATA MUHAMAD KHAWAJA's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against ATA MUHAMAD KHAWAJA or any other concerns with respect to the conduct of the licensee, those matters and report no. 7922 and any updating material, may be brought back before the Tribunal for a full hearing."
