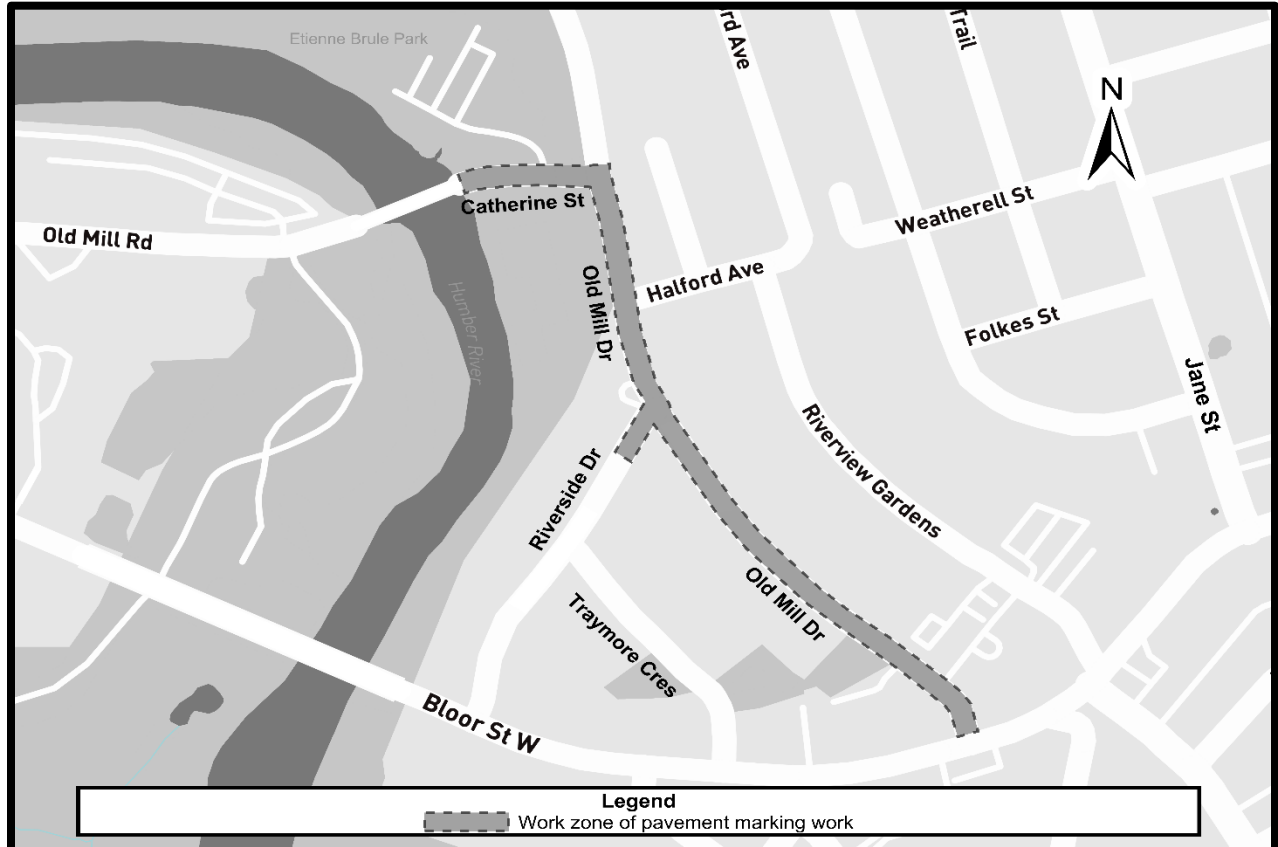

The City of Toronto's work on restoring Old Mill Drive and Catherine Street is progressing well. This notice is to provide an update on the line painting operations. The line painting work is being conducted at night to minimize traffic disruption in the area and reduce vehicles from driving over the fresh line paintings before they dry as needed.




From **Thursday, May 16 at 7 p.m. to Friday, May 17 at 7 a.m.** the contractor will commence painting the pavement markings on Old Mill and Catherine Street. The Contractor is permitted to work 24 hours a day until the work can be completed and the roadway open to traffic. When this overnight work is complete, regular work hours will resume. Your patience and understanding is appreciated during this disruption. Thank you for your patience during this overnight work.

WHAT TO EXPECT DURING CONSTRUCTION

- Wet traffic paint on the road may splatter your vehicle if crossed before the paint has dried; therefore, drivers are reminded to obey all signage and warning signs to avoid paint damage.
- After the completion of the line painting, it is requested that vehicles or pedestrians avoid stepping on the fresh paint for a period of approximately 1 hour. We appreciate your patience.
- Construction noise may occur due to the painting truck and equipment.
- Flaggers will be in place to redirect local traffic

	<p>Road Access: In order to complete the work in a safe manner, there will be road restrictions within the work zone. Access for emergency vehicles will be maintained at all times.</p>
	<p>Traffic Management: Road users should expect delays due to rolling closures and painting equipment, crew and truck. Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.</p>
	<p>Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.</p>
