

Shelter Programming Updates

- Recent programming available to all residents:
 - Art Therapy
 - AA Meetings
 - Mothers and Father's Day celebrations
 - Imagine Health Clinics (Diabetes, self-care, foot health and anger management workshops)
 - Salsa Classes
 - Barber and haircutting volunteer
- 69 residents who are refugee claimants at Delta Shelter (Current total 374)
- Programming to support newcomers:
 - Newcomer Day
 - The Neighbourhood Group housing and settlement services
 - Day trips to various city attractions
- Access to Housing Pilot
- Additional housing support services provided by the City of Toronto
- Service Canada and Coordinated Access clinics to help seniors and referrals to other local services

Council Direction on 2035 Kennedy Road

- In February 2024, Council adopted a number of motions related to the temporary shelter at 2035 Kennedy Road, directing City staff to:
 - transition the site to provide shelter services for refugee claimants
 - increase safety supports on-site and in the surrounding community
 - prioritize the decommissioning of the site and end its shelter use by December 31, 2025





Transition to Refugee-Claimant Shelter Services

- As of February 15, 2024, all new admissions to the 2035 Kennedy shelter program have been refugee claimants.
- City staff and Homes First housing workers have been working with clients to support housing applications and needed documentation, and this work will continue.
- Refugees are being referred to vacant spaces only as they become available.
- As of June 17, there were 374 clients of which 69 are refugee claimants.
- In support of this shift, Homes First has put additional supports in place to assist refugee claimants with their specific needs.





Closure Planning

- Near the end of October 2024, new admissions to the program will cease.
- This will enable staff to gradually decommission the site over a 12-month period, which will help support the most positive outcomes for clients and the broader community.
- From the close of new admissions, we will decant 1-2 floors per month
- The City, in partnership with Homes First, has been working with residents to apply for housing and secure required documentation as part of the development of individualized relocation plans.
- These plans could include a move to another shelter or transition to permanent housing. All relocations are planned to be completed by October 31, 2025, with the full removal of all equipment and return of the site to the landlord prior to December 31, 2025.

Increased Safety Supports

- Incident Reduction: Over the past 4 months (Feb-May 2024), we observed a decrease in violent incidents.
- Paid Duty Officers: Stationed within the shelter program for the first and last four days of each month.
- Community Safety Teams (CSTs): Three teams engaging with shelter residents and community members to address safety concerns. Monitoring locations include:
 - Delta Hotel property (24/7)
 - Delta Metrogate and Village Green Square (12/7)
 - Delta Kennedy Commons and Delta Agincourt Village Community (12/7)
 - Agincourt Mall and Plaza and the West Highland Creek Corridor were added in April.



Increased Safety Supports Continued

- Safety Threat, Risk and Vulnerability Assessment: The City has also hired a third-party consultant to complete a Safety Threat, Risk and Vulnerability Assessment of the Delta Hotel and surrounding community to identify potential security enhancements.
- **Ongoing Collaboration:** Collaboration with the City's Encampment Office so that street outreach staff can be dispatched to connect with individuals to offer services, supports and indoor referrals.
 - City Staff has established monthly touchpoints with Toronto Police 42 Division to review results provided by the Community Safety Teams. These meetings help in arranging community-directed uniformed patrols to address ongoing issues observed in the area.
- **Reporting**: Updates on these and other safety initiatives will be provided in Q3 as requested by Council.
