Overnight Line Painting on Old Mill Drive and Catherine Street



Start Date: June 2, 2024, 7 p.m. End Date: June 3, 2024, 7 a.m. *Timeline is subject to change.

The City of Toronto's work on restoring Old Mill Drive and Catherine Street is progressing well. This notice is to provide an update on the line painting operations. The line painting work is being conducted at night to minimize traffic disruption in the area and prevent vehicles from driving over the fresh line paintings before they dry.

From **Sunday**, **June 2**, **2024** at **7** p.m. to **Monday**, **June 3**, **2024**, at **7** a.m. the Contractor will remove the temporary stop bar and crosswalk markings and replace them with permanent markings on Old Mill Drive and Catherine Street. The Contractor is permitted to work 24 hours a day until the work can be completed. When this overnight work is complete, regular work hours will resume. Your patience and understanding are appreciated during this disruption. Thank you for your patience during this overnight work.

WHAT TO EXPECT DURING CONSTRUCTION

- Wet traffic paint on the road may splatter your vehicle if crossed before the paint has dried;
 therefore, drivers are reminded to obey all signage and warning signs to avoid damage.
- After the completion of the line painting, it is requested that vehicles or pedestrians avoid stepping on the fresh paint for approximately 1 hour. We appreciate your patience.
- Construction noise may occur due to the painting truck and equipment.
- Flaggers will be in place to redirect local traffic.



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road restrictions within the work zone. Access for emergency vehicles will be maintained at all times.

Driveway Access: The Contractor will notify you of any temporary restrictions to your driveway access.



Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, inform the contact listed below.
