# BACKGROUND

St. Felix Centre, with support from the City of Toronto, will open a shelter for people experiencing homelessness at 629 Adelaide Street West in the Fall of 2024. The shelter will have the capacity for 50 people and will provide comprehensive case management and programming support for all clients, with a focus on helping people secure permanent housing.

This site is a relocation of shelter services previously operated by St. Felix Centre at 25 Augusta Avenue. The Augusta site closed in July 2023 and is in the process of being converted into new affordable housing.

A Community Engagement process was initiated by the City of Toronto to inform and engage local community members around the operation of the shelter to be located at 629 Adelaide Street West, and to provide an opportunity for the community to become involved in ensuring the success of the shelter in the neighbourhood.

The City and St. Felix Centre have made several adjustments to continue supporting people experiencing homelessness and address feedback received regarding 629 Adelaide St W through engagement activities in Fall 2023. A variety of factors influenced the change to the service model, including community feedback, available budget, and a further assessment of the layout and square footage of the space.

A key community engagement activity for this site was the coordination of a Community Walk. The primary purpose of the Community Walk (henceforth also referred to as "the Walk") is to ensure representatives from various local stakeholder groups collectively identify areas of concern in the community that may be impacted by the upcoming shelter program and begin a process of addressing those concerns.

This report outlines the planning process as well as observations and recommendations of all participants involved in the Walk held on May 6, 2024.



# **COMMUNITY WALK PLANNING GROUP**

A planning group was established to organize the Community Walk. Barnes Management Group facilitated the Community Walk Planning Group Meetings. The planning group met to outline all aspects of the Community Walk to be held on May 6, 2024.

The planning group consisted of representatives from:

- Toronto Shelter & Support Services Division (TSSS), City of Toronto
- Deputy Mayor Malik's Office
- St. Felix Centre
- The Community Safety and Wellbeing unit from the Social Development, Finance and Administration Division, City of Toronto
- Toronto Police Services.



# **COMMUNITY REPRESENTATION**

The Planning Group aimed to ensure inclusivity in the Community Walk. To achieve this, the planning group identified a broad cross-section of key community stakeholders in the vicinity of the site. As a typical practice for community engagement, invitations were extended to one representative from each of these groups. This resulted in the participation of 16 stakeholder groups in the Community Walk.

The specific stakeholder groups invited to participate in the Walk included:

Community Walk participants also included Deputy Mayor Ausma Malik, along with three representatives from her office. Toronto Alliance Church and St. Mary's Parish representatives were unable to join the Walk due to a scheduling conflict. However, they expressed their support for the shelter and their willingness to assist in its successful integration into the community. Similarly, the representative from the Queen West B.I.A. was unable to attend the Walk on the planned date but has provided input through other engagement opportunities.

Prior to the Community Walk, all confirmed walk participants received a detailed e-mail outlining key aspects related to the planned Walk, including the purpose of the Walk, the anticipated duration, and the expected code of conduct.



# THE COMMUNITY WALK

The Community Walk was held on May 6, 2024, at 11:00 AM and was approximately 1.5 hours long. The Walk participants were divided into two groups to ensure manageable sizes for navigating through the community streets and sidewalks safely and effectively. Before starting the Walk, a brief overview, of key details, was shared, including the route, conduct expectations and a round of introductions of all the Walk participants. Barnes Management Group served as walk leaders, guiding participants along the predetermined route. Staff from TSSS took notes for all groups.

The Community Walk route is visualized below:

Group 1 starting point – Niagara Street Junior Public School Group 2 starting point – Stanley Park, at the intersection of Adelaide Street West and Walnut Avenue

Multiple individuals who had not been invited joined the Walk. TSSS staff and representatives from Toronto Police Services, 14 Division and these individuals created a third group that followed the designated route. In total 13 people joined the additional Walk and their feedback was captured in notes taken by staff from TSSS.



# **FINDINGS**

Key findings from the Community Walk were consistent across all three groups. A consolidated list of all the concerns identified and proposed recommendations is captured in *Appendix "A*".

Areas of concern focused on six primary themes: the shelter facility, schools, drug use, sharps and drug paraphernalia, traffic, lighting, and private property.

It is important to note that the concerns identified during the Walk are complex and multifaceted across various neighbourhoods in the City of Toronto, and are standing concerns in the area.

The recommendations in this report will be shared with the appropriate stakeholders. Concerns related to shelter operations will be shared with St. Felix Centre and Toronto Shelter & Support Services Concerns involving municipal infrastructure and operations will be directed to the appropriate City divisions and partners.

A significant amount of suggestions were related to the use of Community Safety Team (CST). CSTs monitor a specific catchment area, often 24/7. The primary objectives include aiding shelter guests, fostering safer community environments, and addressing concerns like the safe disposal of used needles and drug-related items. CSTs consist of frontline workers who bring a compassionate, patient, and non-judgmental attitude to their roles.

#### Shelter Facility – 629 Adelaide Street West

Walk participants toured the surrounding area around the shelter facility including the adjacent laneways. Several participants in the Walk recommended that the boulevard area on the north side of the shelter building be considered for development into an enclosed private space for shelter guests. Fencing around this area could provide privacy and prevent obstruction of the walkway for pedestrians.

There was concern that the laneways on the south and west sides of the shelter were littered with garbage and used clothing. Additional lighting and security cameras, a parabolic mirror and motion sensors were



recommended. These installations should consider the townhouse residents backing onto the south end of the laneway.

Toronto Hydro maintains an underground electrical plant and vent system maintenance vault at the southwest corner of the laneway. Individuals are known to congregate in areas like this and garbage can accumulate. Areas of responsibility and recommendations are detailed in *Appendix "A"*.

#### Schools

Walk participants met directly with the principals of St. Mary's School and Niagara Street Junior Public School during the Walk. Both principals toured the group around their properties and shared concerns related to the respective schools. Some of the key issues at both schools related to adequate fencing and health and safety risks for their students due to the dangers of sharps and drug paraphernalia found on their properties.

Work is currently underway by the school to address these issues, and ongoing meetings are planned with representatives from both schools and the City of Toronto.

Furthermore, it was discussed that the Community Safety Teams (CSTs) prioritize schools along the catchment route, and work with St. Felix to determine a schedule for proactive patrols and for being responsive to community calls. CSTs will collaborate with existing services in the community to minimize overlap of activities.

## Drug Use, Sharps and Drug Paraphernalia

All Stakeholder Groups and Community Walk participants have voiced concerns regarding the proliferation of sharps and drug paraphernalia found in several locations throughout the area; particularly in the areas surrounding the two schools. Community Safety Teams are recommended to support the collection of sharps and drug paraphernalia within the designated area, with recommendations that special attention and priority should be given to the vicinity of schools, the shelter site, and neighbouring properties around the shelter.

#### Traffic

During the Community Walk, significant concern was expressed about the speed of vehicular traffic progressing around Adelaide St W and Portugal Sq. These concerns are heightened by the fact children are often walking



along these streets to and from school, as well as local pedestrian traffic moving throughout the neighbourhood. To address traffic and safety risks, recommendations to implement traffic calming features such as stop signs, speed bumps, crossing guards, and additional police presence were made.

#### Lighting

Several locations along the Community Walk were identified as requiring enhanced lighting in private property, sidewalks, and laneways. Recommendations were made to conduct additional environmental scans, especially during the evening, to assess lighting needs in public spaces more comprehensively. Property owners are responsible for maintaining lighting on their private property.

#### Private Property

A significant portion of concerns identified by all three groups related to issues observed on private property. Given the current and specific layout of many of these properties and spaces, they are perceived as vulnerable locations for loitering, congregating, or trespassing. Walk participants raised concerns that they could be potential locations for drug use, theft, and mischief.

Recommendations include considering incorporating a walk-by for some of the areas surrounding private property within the catchment area of the Community Safety Teams. However, it is important to note that Community Safety Teams are not authorized to visit or patrol private properties. Property owners are responsible for the maintenance of their space. In case of safety issues or incidents of trespassing, immediate contact with 911 or using the Toronto Police Online Reporting Tool: Online Reporting - Toronto Police Service (https://www.tps.ca/services/online-reporting/) is recommended. Neighbourhood Community Officers (NCOs) work in partnership with local residents and community-based organizations to address crime, disorder and community safety issues. Acting as ambassadors for the Toronto Police Service, they work collaboratively with residents as well as community agencies to build sustainable solutions.



## **RECOMMENDATIONS FROM BARNES MANAGEMENT GROUP**

The extensive amount of information gathered during the Community Walk, along with the detailed sharing beforehand, demonstrates the significant concern and passion that exists among community members. It also highlights the urgency they feel with respect to finding solutions to many of these issues.

Throughout the Community Walk, many synergies and examples emerged as to how a well-coordinated and collaborative approach could be developed between community members, the shelter operator, and many of the existing services and supports in the neighbourhood. This could be a powerful resource to bring people together to find solutions to several of the concerns identified during the Community Walk.

A consolidated list of all the concerns raised during the Community Walk is identified and proposed recommendations are captured in **Appendix "A".** The recommendations below are high-level recommendations from Barnes Management Group. Barnes Management Group submits the following:

- 1. The City of Toronto, St. Felix Centre, and the two schools in the area to meet regularly to ensure that concerns identified by the schools are considered for action and progress is communicated.
- 2. A meeting be held to bring existing community safety teams and resources together to review and explore opportunities to better integrate and utilize the resources they currently provide in the community. Coordination is required to bring existing and future Community Safety Teams together, aiming to review and explore opportunities for improved integration and utilization of shared resources.

The coordination and collaboration of resources and schedules among the various Community Safety Teams, Consumption Treatment Services, School Custodial staff, and Outreach services available through Parkdale Queen West Community Health Centre and the shelter could result in a broader, more frequent, and consistent approach to safety activities throughout the



neighbourhood. This could also expedite the pickup and safe disposal of sharps, drug paraphernalia and other items of concern.

- 3. The creation of a Who To Call Sheet outlining various services and their respective contact details. Distribute this sheet to community representatives and members who can call for assistance.
- 4. The formation of a Community Liaison Committee for the shelter to explore opportunities to facilitate collaboration between the shelter, community residents, schools in the area, the faith community, and other services in the community to assist in the successful integration of the shelter into the community.
