Certified candidates are entitled to an electronic copy of:

- The Preliminary List of Electors
- Interim List of Changes (only applies in a regular election)
- List of People who Voted at Advance Vote
- List of People who Voted by Mail-In Ballot

This completed form must be provided to Toronto Elections prior to receiving the voters' list.

<p>I declare that in accordance with the Municipal Elections Act, 1996, section 23(7) and (8):</p> <ul style="list-style-type: none"> • I will only use the voters' list for electoral purposes and shall not use it for commercial purposes. • I will only disclose the contents of the voters' list to others after obtaining their written acknowledgement that they will adhere to the restrictions set out in the Municipal Elections Act, 1996. • I understand that if I provide the contents of the voters' list to another person: <ul style="list-style-type: none"> ○ They will not provide the voters' list to any other person and will not make any further copies, either electronically or in printed format. ○ If they receive a printed copy, they will return it to me on or before the day my campaign ends. ○ If they receive an electronic copy, they will destroy it and provide me with written acknowledgement of the destruction of the voters' list on or before the day my campaign ends. • If I do provide the voters' list to another person, I will retain all written acknowledgements provided by each person for the term of office of the council or local board. <p>I will, on or before the end of the campaign period:</p> <ul style="list-style-type: none"> • Destroy the copy of the voters' list provided to me, and • Destroy any printed copies and obtain written acknowledgement from anyone provided with an electronic copy of the voters' list that they have destroyed their copy. Any such written acknowledgement of destruction must be retained for the term of office of the council or local board. <p>I acknowledge Municipal Elections Act, 1996, sections 23(7) and (8) contains additional restrictions that I have read and understand.</p> <p>I _____ (Candidate's Name – First and Last or Single) acknowledge that I have read and understood the voters' list restrictions and agree to comply with the Municipal Elections Act, 1996, sections 23(7) and (8).</p>
