Toronto Local Appeal Body – Proposed Amendment to the TLAB's Decision-Writing Template

Summary

The Toronto Local Appeal Body will consider incorporating the proposed additional wording under the subheading – **The Legislative and Policy Framework** - in the Decision-Writing template. The wording will reference having regard to matters of provincial interest, as enumerated in **s. 2** as (a) - (s).

Member Kanter mentioned that the template makes reference to the Provincial Legislation policies in section 2, and that to be complete and reflect the interests of parties and obligation of members, this should be included.

Member Yao mentioned the disadvantages of raising the provincial interests (ex. memo of understanding our decisions have to be understandable to the public.)

Member Swinkin supported Member Yao advising that it may give rise to apprehension of public section 2 a test, which is not the case.

Chair Lombardi advised that the decision writing template sent to Members is pre-populated and it is at the Members' discretion to review that pre-populated section and determine if different sections are relevant.

The Toronto Local Appeal Body – Impacts of Bill 23 – *The More Homes Built Faster Act, 2022,* on the current workload of the Toronto Local Appeal Body Panel Members

Summary

Since the introduction of Bill 23 – *The More Homer Built Faster Act, 2022*, which eliminated 'third-party' appeals to the Toronto Local Appeal Body (TLAB), the Tribunal has experienced a significant decrease in the number of appeal files received from the four Panels of the City's Committee of Adjustment.

While the TLAB has also seen a reduction in its Panel Member complement in the interim due to resignations, the assignment of files to the sitting Members continues to decline well below the expected two (2) hearings per week standard described in the position description.

The City of Toronto has posted the intention to fill four current vacancies in the TLAB Panel complement.

The TLAB Members submit that the City of Toronto should pause the process to fill these four vacancies until an understanding of the impacts of the reduced caseload resulting from the Committee of Adjustment (COA) Appeals can be established.

Vice Chair Bassios is in support of the proposed Motion to pause the appointment of new TLAB Members.

Chair Lombardi asked if there is any process in terms of an evaluation of analysis whether additional Members to fill vacancies is warranted.

Manager Halloran advised of a time consideration, and data required. If reduction in the number of appeals being received continues then the reduction in size of the TLAB may be reviewed by the City.

Chair Lombardi is pleased to hear there is a process on the way but noted that he has not been contacted for input in this regard. The Chair has recently reached out to the Public Appointments Secretariat to express concerns regarding the appointment of additional members to the TLAB and does appreciate that the communication has been received. Both Vice-Chair Bassios and Member Tassiopoulos abstained from voting on the proposed Motion as they are currently under consideration for reappointment to the TLAB.

Chair Lombardi is hoping that this motion will assist with being heard.

Toronto Local Appeal Body – Proposed Addition of a New Rule 27.5 to the Toronto Local Appeal Body's *Rules of Practice and Procedure*

Summary

A new Rule 27.5 is proposed to address situations regarding the failure of a Party of record or that Party's representative to arrive on time at the commencement of a Hearing, whether that be an 'inperson' or 'virtual' hearing event. The draft new Rule outlines the procedure to be instituted by the presiding Member in the event of such a situation.

This is a matter raised by Member Swinkin as a result of a situation he experienced regarding an applicant who failed to show on the hearing date and did not formally withdraw. There is currently no TLAB rule providing direction for Members when applicants do not attend at the commencement of a Hearing and the Hearing is delayed as a result.

Vice Chair Bassios expressed concern about embedding this in the rules and suggested leaving it to the discretion of the panel Members.

Chair Lombardi supports the Motion to add a new Rule to provide clarity for citizens as to what procedure will be followed.

Member Swinkin clarifies that his suggestion is the time to be fifteen (15) minutes in the rules.

THAT the Toronto Local Appeal Body add the following new Rule 27.5 under the 'CONDUCT OF PROCEEDINGS' section of its Rules of Practice and Procedure (December 2, 2020, as amended):

New Rule 27.5 – The TLAB will not proceed for at least thirty (30) minutes after the commencement time given in the Notice of Hearing for an 'in-person' if a Party of record or that Party's

representative, confirmed to the TLAB pursuant to Rule 14 of its Rules of Practice and Procedure, has not yet appeared, unless prior notice has been given to the TLAB that the person will not attend at the scheduled time.

The TLAB will not commence an electronic Hearing for a period of fifteen (15) minutes after it is scheduled to begin should a Party of record or that Party's representative not be connected to the proceeding at that time.

The TLAB may start the Hearing after waiting the requisite time for that format of the hearing event.
