DECISION:

The Tribunal approved the request for an extension of Taxicab Owner's Licence No. V00-5203682; Taxicab Plate No. 4319 submitted by the Estate of Rajadurai Gajendran to remain in the Estate until March 15, 2025.

DECISION:

The Tribunal approved the joint Proposed Resolution, on consent, as follows:

- (1) "The Parties agree that Taxicab Owner Licences V02-4960962 and V02-4960963 will be extended until March 23, 2025;
- (2) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 60 days of the Tribunal hearing, failing which the licence may be cancelled;
- (3) A vehicle must be registered to plate no. 2051 and 2070 or the plates must be returned to Municipal Licensing and Standards at 850 Coxwell Avenue, 3rd Floor, Toronto, Ontario within 60 days of the Tribunal Hearing, failing which the licences may be cancelled;
- (4) The estate trustee must provide MLS with an update regarding the status of the plates at least eight (8) weeks prior to the licences expiring (ie. by January 28, 2025) by emailing <u>mlsconditionreporting@toronto.ca</u>."
