Toronto Local Appeal Body – The Toronto Local Appeal Body Chair's 2022 Annual Report

#### Summary

The Toronto Local Appeal Body (TLAB) Chair prepares and submits a report of the operations of the TLAB on an annual basis to City Council which provides a summary of the activities of the Tribunal over the past year.

The TLAB Chair's 2022 Annual Report was considered by the City's Planning and Housing Committee on September 28, 2023, and by City Council on October 12, 2023. The 2022 Annual Report was accompanied by a Report for Action, prepared by senior City Staff, dated September 14, 2023, which transmits the Chair's Annual Report from the TLAB Chair to City Council for information purposes.

Chair Lombardi advised that he attended the meeting and provided Planning and Hosuing Committee Members with an abbreviated overview of the Annual Report and requested the Members to adopt the five (5) Recommendations in the Annual Report.

Vice Chair Bassios stated that the (the decision makers are not focused on TLAB's functioning and) Chair decision makers are limited in their focus and that attention to functioning or performance is not high on the agenda, and noted her concerns regarding the feedback on how members can have better access to TLAB and CoA resources.

Member Kanter expressed surprise at the disconnection between the Recommendations in the Chair's Annual Report and the City's recommendation. It should have been a courtesy to respond or comment on the Chair's proposals.

Veronica Edwards confirmed that City legal will attend all Business Meetings and will provide support at the request of the Chair and the request of staff.

Member Kanter asked if the hiring of more members is still scheduled to occur before the end of this year.

Veronica Edwards spoke about the Panel Member compliment increase from 10 to 14 based on a 2020 recommendation to Council. The City Clerks division is currently undertaking recruitment and will be shortlisting candidates based on the actual numbers that were put forward by City Council.

Veronica Edwards advised that City clerks will move on the recommendations from Council

Chair Lombardi confirmed that he will be meeting in November with the new Director of Court Services, Dianne Karias, and that this will be one of the issues discussed.

Toronto Local Appeal Body – Proposed Draft Revisions the Toronto Local Appeal Body's Practice Direction No. 3 – Document Referencing

### Summary

The proposed draft revisions to the wording of Practice Direction No. 3 of the Toronto Local Appeal Body (TLAB) are intended to incorporate additional procedures for Persons filing documents with the TLAB to assist in reducing the time required by Members to conduct hearings and to review and reference pre-filed documents.

Member Kanter had a concern with respect to the excerpt regarding tabs and their usefulness when receiving document submissions.

Member Swinkin wouldn't discourage use of tabs, and finds them particularly useful, but notes the creator must organize them well.

Member Yao suggested a friendly amendment be added to the draft Motion to include bylaws of the former municipalities.

Vice-Chair Bassios suggested the Members leave the draft Motion as is. Member Kanter acquiesced to that friendly Member's suggestion and reconsidered his request to amend the draft Motion.

### 44.5 – SUPERVISOR AND MANAGER'S UPDATE

### Summary

The Court Services Tribunal Supervisor and Manager to provide an update on Administrative Matters:

Acting Supervisor Claire Holloway shared some of the updated TLAB Forms updates which align with Bill 23 changes, namely the Notice of Appeal and the Notice of Motion.
