

# Rehabilitation of Don Valley Parkway Ramp over Bayview Avenue Extension and Road Resurfacing on Bloor Ramp between Bayview Avenue to Don Valley Parkway

Contract: 24ECS-BE-12PM
Start Date: August 2024 End Date: May 2025

The City of Toronto is planning to rehabilitate the Don Valley Parkway Ramp Bridge over Bayview Avenue Extension and Road Resurfacing on Bloor Ramp between Bayview Avenue to Don Valley Parkway. This work will ensure that the bridge and road meet today's standards and remain safe into the future. The project is part of the Council-approved 2024 Capital Works Program.

## **WORK DETAILS**

The City's contractor will:

- Repair and refurbish the Don Valley Parkway Ramp Bridge over Bayview Avenue Extension and Road Resurfacing on Bloor Ramp between Bayview Avenue to Don Valley Parkway.
- Reconstruct the concrete parapet walls, railings, and approach slabs
- Patch repair the concrete deck, and the substructure's piers, abutments, and wingwalls
- Replace bridge bearings
- Replace the asphalt surface and waterproofing
- Improve bridge approaches and drainage
- Replace the asphalt on the Bloor Ramp

#### WHAT TO EXPECT DURING CONSTRUCTION

## **Construction Notice**



**Work Hours**: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, 9 a.m. to 7 p.m., Saturdays. No work will occur on Sundays and Statutory holidays.



**Pre-Construction Inspection:** The City hired contractor will conduct inspections of properties within 30 metres of the construction area before construction starts. Affected properties will receive a separate notice to set up an appointment for the inspection.

The inspection will look at the exterior and interior of properties to verify existing conditions. Although participation is voluntary, the City encourages all property owners to participate. Without the survey, it will be difficult to confirm any claims of damage caused by construction. All inspection staff will wear photo I.D. and carry photo equipment for this work.



**Traffic Management**: Road users should expect delays and increased traffic on nearby main and side streets. Motorists are reminded that bicycles and cars will be sharing the lane. When driving, please be mindful of vulnerable road users.

 A minimum of two traffic lanes (one in each direction) on Don Valley Parkway ramp and Bayview Avenue will be maintained at all times during construction



**Accessible Accommodation:** The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the **Field Ambassador** listed below.



**Restoration:** The construction work area will be restored with sod, concrete and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
