In order to process your application, please submit the following:

- The 2024 non-refundable administrative fee of \$104.56 + \$13.59 (13 %HST) = \$118.15 *per publication dispensing box* by cheque or money order payable to the Treasurer City of Toronto;
- Two (2) coloured drawings & photographs of the proposed installation, clearly showing height, width and depth dimensions; and
- Two (2) separate written confirmations from (1) print source and (2) publication company verifying recycled fibre content of paper used for each publication. Council mandate specifies 40% minimum.

Upon approval of your application, it will be necessary to:

- Pay the 2024 annual license fee <u>per box per location</u> for the publication dispensing boxes \$41.10 + \$5.34 (13%HST) = \$46.44 **For each additional box after 100 boxes** \$164.24 + \$21.35 (13%HST) = \$185.59
- Enter into a legal agreement with the City of Toronto;
- Provide a third-party liability insurance policy satisfactory to the City Treasurer

All fees are subject to an annual increase based on the Consumers Price Index (CPI) plus HST, City of Toronto HST Registration No. 86740 2299 RT0001.

Personal Information on this application is collected under the authority of the Province of Ontario Municipal Act, R.S.O. 1990, c.M.45, and City of Toronto Municipal Code Chapter 743, "Use of Streets and Sidewalks". It will be used for administrative and enforcement purposes in connection with your application.
