Comments	The Chief Financial Officer and Treasurer has reviewed this DAF and agrees with the financial impact information.  The sidewalk is located in 21 private properties along the Eglinton Avenue West corridor, primarily in the vicinity of Chaplin Crescent, Bathurst Street and Dufferin Street. Transportation Services requires the acquisition of these properties because, although privately owned, they appear to be, and are used as public sidewalk.  At its meeting on June 26 and 27, 2024, City Council adopted GG13.12 which authorized the exemption from General Conditions (G) and (H) of Appendix B of Toronto Municipal Code Chapter 213, Real Property, to carry out environmental due diligence on the properties and approved additional compensation for each owner's legal fees to a maximum of \$5,000 inclusive of Harmonized Sales Tax.  The Property is located within the vicinity of Chaplin Crescent. Negotiations have been completed and agreement reached with the Owner to acquire the Property.  The Offer is considered fair, reasonable and reflective of market value, and it is recommended for acceptance substantially on the major terms and conditions set out in below.  Irrevocable Period: The period of time ending at 11:59 p.m. on the Business Day next following 60 days after the Owner's execution of the Offer.
