Dear Julie,

On behalf of the Eglinton East Light Rail Transit (EELRT) project team, I am following up on our previous communication and your request for a filing fee in relation to the Transit and Rail Project Assessment Process (TRPAP) for the EELRT.

As you know through our email correspondence, it was our initial intention to pay the filing fee and submit the notice of request to consult for Alderville First Nation. However, based on an internal administrative review, we have received clarification that the City of Toronto is not authorized to provide funds to review studies and reports related to the EELRT TRPAP. Please accept my sincere apologies for the confusion and protracted communications regarding this matter.

As you are aware, the City of Toronto is completing its consultation obligations under the TRPAP as prescribed by *Ontario Regulation 231/08* and as required the Ministry of Environment, Conservation and Parks (MECP). This process does not include the provision of payments to review studies and reports.

It is the City of Toronto’s role under TRPAP to consult and report to the Province, thus, it would be appropriate, should Alderville First Nation choose, for you to further discuss concerns around payments for reviewing studies and reports with the Province.

At this time, the EELRT project team has prepared a pre-assessment document (see attachment) which will be included in the final Environmental Project Report (EPR) to be issued for review at the TRPAP Notice of Completion and provides a summary of the anticipated impacts and proposed mitigations of the EELRT project that the project team understands may be of interest to Indigenous communities. The summary is based upon the scope of work performed to date on the project, along with feedback received from Indigenous communities through several meetings and presentations.

This pre-assessment gives an overview of impacts along with a summary of proposed mitigation measures in the following categories:

- Natural Environment
- Built Heritage Resources and Cultural Heritage
- Archaeological Resources

The pre-assessment notes that a Stage 2 Archeological Assessment will be undertaken at a subsequent design phase, which will include further consultation with Indigenous Communities. The current TRPAP phase of work has been limited to Stage 1 Archaeological Assessment.

Please note that the primary information required by Alderville First Nation’s Consultation Protocol’s Notice of Request to Consult is included in this pre-assessment document.

The EELRT project team understands that this document is based on our interpretation of Indigenous community interests that have been expressed to us and we welcome, on an ongoing basis, the identification of any other areas of interest, any areas where further information would be helpful, or anything that you feel has been missed in this pre-assessment for Indigenous communities.

The City of Toronto is committed to engaging with Indigenous communities through the conclusion of the current project assessment process as prescribed by *Ontario Regulation 231/08* and ongoing through future required assessments through the completion of the project.

We anticipate launching the 30-day review period of the EPR this month and will provide further notice.

On behalf of the Eglinton East Light Rail Transit (EELRT) project team, I am following up on our previous communication about the Transit and Rail Project Assessment Process (TRPAP) for the EELRT.

I trust that you received the presentation overview of the EELRT in PDF format and the Stage 1 Archeological Assessment report sent on April 25, 2024.

Today, I am writing to share a pre-assessment document (see attachment) which will be included in the final Environmental Project Report (EPR) to be issued for review at TRPAP Notice of Completion and provides a summary of the anticipated impacts and proposed mitigations of the EELRT project that the project team understands may be of interest to Indigenous communities.

The summary is based upon the scope of work performed to date on the project, along with feedback received from Indigenous communities through several meetings and presentations.

This pre-assessment gives an overview of impacts along with a summary of proposed mitigation measures in the following categories:

- Natural Environment
- Built Heritage Resources and Cultural Heritage
- Archaeological Resources

The pre-assessment notes that a Stage 2 Archeological Assessment will be undertaken at a subsequent design phase, which will include further consultation with Indigenous Communities. The current TRPAP phase of work has been limited to Stage 1 Archaeological Assessment.

The EELRT project team understands that this document is based on our interpretation of Indigenous community interests that have been expressed to us and we welcome, on an ongoing basis, the identification of any other areas of interest, any areas where further information would be helpful, or anything that you feel has been missed in this pre-assessment for Indigenous communities.

The City of Toronto is committed to engaging with Indigenous communities through the conclusion of the current project assessment process as prescribed by *Ontario Regulation 231/08* and ongoing through future required assessments through the completion of the project.

We anticipate launching the 30-day review period of the EPR this month and will provide further notice.
