Information may include patient identity, personal health information, patient assessment findings, type of care provided, the patient's response to treatment, and name and address of the hospital the patient was transported to.	This report may be disclosed to the patient, Power of Attorney, a person authorized by the patient, or their legal representative.	\$31.00 each (disclosed to individual only) \$84.00 each (disclosed to their legal representative)
Incident Summary Report	Ambulance Dispatch Record showing location of call, time of call, etc. Information may include incident address and general incident details.	This report may be disclosed to the patient, Power of Attorney, a person authorized by the patient, or their legal representative.	\$47.00 each

Audio recordings of incoming calls to Toronto Paramedic Services	Audio recordings of the incoming request for emergency service. Information recorded may include details relating to the patient.	Audio recordings may be disclosed to the patient, Power of Attorney, a person authorized by the patient, or their legal representative.	\$84.00 each
Incident Reports	(Where available) Additional Report completed by paramedics under prescribed circumstances. Information may include location of the call, and injury/illness of patient.	Incident Reports may be disclosed to the patient, Power of Attorney, a person authorized by the patient, or their legal representative.	\$345.00 each
Statutory Declaration	A legal declaration completed by paramedic(s) in response to a request from the parents of a child born outside of a hospital. Types of information include patient name and mother's name.	A Statutory Declaration may be disclosed to the parents, Power of Attorney, a person authorized by the patient, a legal representative, or the Children's Aid Society.	\$84.00 each
