## Local Road Resurfacing and Major Rehabilitation on Ford Street from Davenport Rd to St. Clair Avenue West; Intersection improvements at Ford Street and Connolly Street

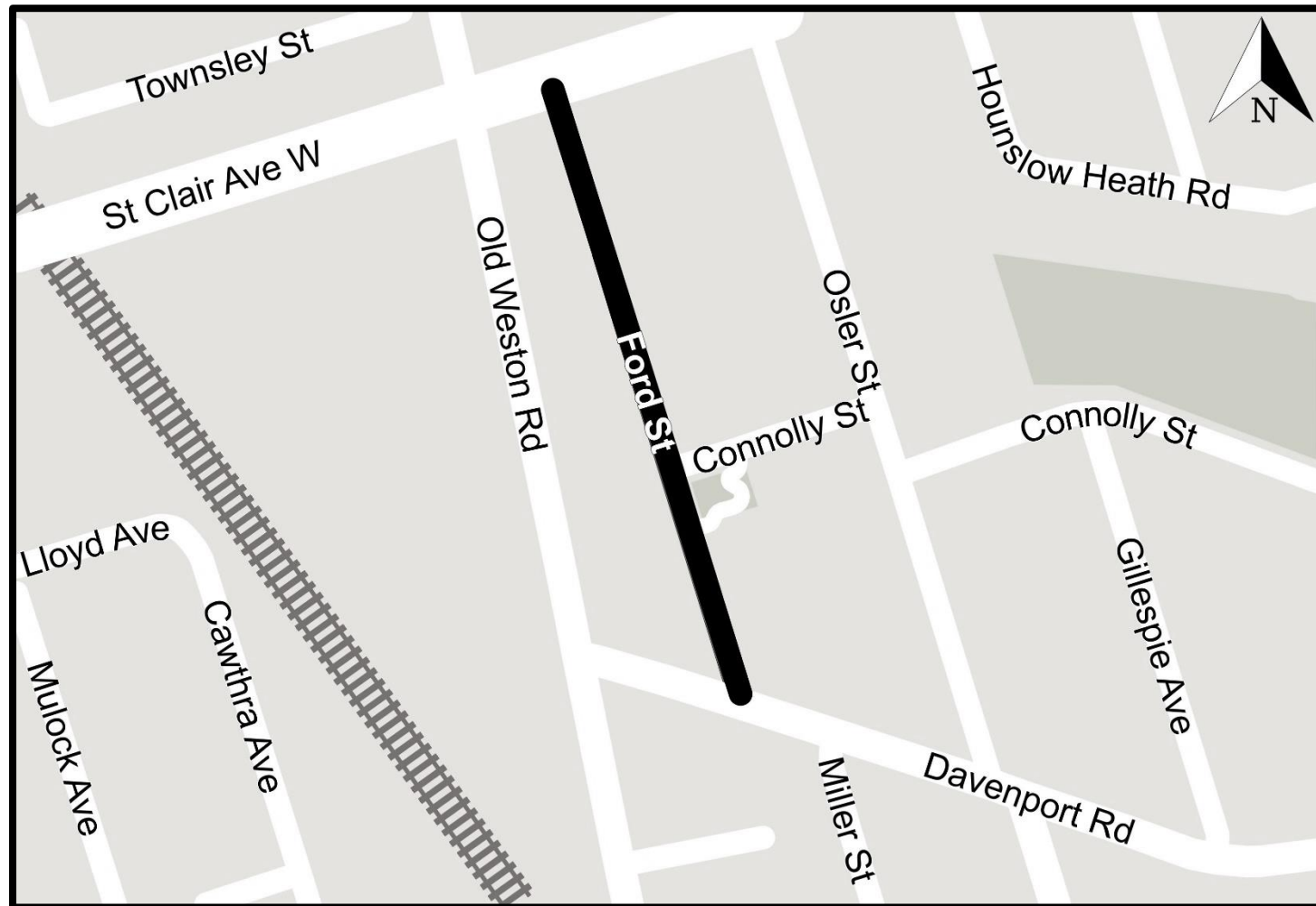

The City of Toronto is planning to resurface and rehabilitate Ford Street from Davenport Road to St. Clair Avenue West. Our inspection of the road shows that it needs repaving, and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

The City also plans to make improvements to the intersection of Ford Street and Connolly Street. This will improve the geometric characteristics and pedestrian safety at this intersection.


This project is part of the Council-approved 2024 Capital Works Program to renew aging City roads and sidewalk for current and future needs.

### WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark curbs requiring replacement and the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information about the work.
- **The City will not be responsible for damage to any privately owned items on City property.**

	<p><b>Accessible Accommodation:</b> The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the <b>Local Roads Enquiries email</b> listed below.</p>

	<p><b>Access to Your Home:</b> The City-hired contractor may need access to the interior and exterior of your home to complete a pre-construction condition survey. Affected properties will receive a request to schedule a time to complete the pre-construction condition survey. Although participation is voluntary, the pre-construction survey results may be useful to confirm claims for potential damage caused by City construction.</p>
	<p><b>Important information for owners of sprinkler systems / heated driveways and private landscaping features.</b> Property owners should remove items located within City property limits (boulevard) to avoid damage.</p> <p>This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. <b>If you have a sprinkler system or heated driveway</b>, please contact the <b>Local Roads Enquiries email</b> listed below.</p>
