TORONTO LICENSING TRIBUNAL ELECTRONIC HEARING: November 28, 2024 (9:30 AM) Summary of Decisions V. Francis

 Scarborough Event Centre Inc. (Report No. 7945) o/a Scarborough Event Centre Ajanthan Thavayogarajah, Director Kajendrakumar Kandasamy, Director Kokilan Vallipuram, Director Applicant for a Public Hall Licence (Application No. C444378)

DECISION:

The Tribunal approved the joint Proposed Resolution signed November 28, 2024, as follows:

"Public Hall Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Public Hall Licence will be placed on probation for a period of four (4) years. Kokilan Vallipuram, Kajendrakumar Kandasamy and Ajanthan Thavayogarajah are advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Scarborough Event Centre Inc., Kokilan Vallipuram, Kajendrakumar Kandasamy and Ajanthan Thavayogarajah and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewal(s) of the licence, Scarborough Event Centre Inc. must provide to Municipal Licensing and Standards, at its own expense, an original up-to-date Criminal Record and Judicial Matters Check for Kokilan Vallipuram;
- (4) During the probationary period, Kokilan Vallipuram must be accompanied by at least one other of the Scarborough Event Centre Inc.'s Directors at all times while on the premises of 5637 Finch Avenue E, Unit 1, Toronto, Ontario M1B 5K9;

(5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Scarborough Event Centre inc., Kokilan Vallipuram, Kajendrakumar Kandasamy, Ajanthan Thavayogarajah or any other concerns with respect to the conduct of the licensee, those matters and report no. 7945 and any updating material, may be brought back before the Tribunal for a full hearing."
