




Investigation of Basement Flooding - Study Area 52

Municipal Class Environmental Assessment Notice of Study Completion

The City of Toronto has completed a Municipal Class Environmental Assessment (EA) study that examines surface and basement flooding within Study Area 52 and identifies improvements that can be made to City infrastructure to reduce the risk of future flooding. The study area is located in the south Scarborough area roughly bound by Highway 401 at the north, Warden Avenue/Kennedy Avenue on the west, Brimley Avenue/Bellamy Road on the east and Lake Ontario to the south. This area has experienced basement and surface flooding during severe rainstorms in the past.



The study followed the Master Planning Approach #2 of the Municipal Class Environmental Assessment and satisfies the requirements for the Schedule B projects. Following consultation with agencies, City divisions and the public, the study recommends six Schedule B projects including:

- Dorset Park Creek Area storm sewer upsizing, including additional catchbasins and outfall reconstructions
- Dorset Park Creek Area sanitary sewer upsizing
- Storm sewer upgrades and diversion in McCowan Park
- Storm and sanitary sewer upgrades through existing easements on private property, where right-of-way alternatives were not feasible
- Various improvements throughout the study area, such as storm and sanitary sewer upgrades, in-line storage pipes, high-capacity inlets, additional catchbasins, dual manhole improvements, and lowering shallow sanitary sewers

The study also recommends two pre-approved/exempt projects that consists of various sewer upsizing projects, increasing the number of catch basins and lowering shallow sewers.
